Mt. Holly School Board Meeting

The Mt. Holly school board met on Wednesday, April 2 at the Ludlow Elementary School Multipurpose Room with the LES board. The boards discussed the pending legislation that will drastically change school governance. The boards felt that it would cause a loss of local control and disconnect the school board from the community. Both boards opposed the legislation and planned to speak with the supervisory union board to discuss sending a resolution in opposition to the legislators.

After the LES board adjourned, the Mt. Holly board discussed the planned solar project as well as an additional solar project that can be done in conjunction with the planned project. The planned 10 kW project has a curriculum element that the school board would like to optimize. The board discussed the different location, inverter, vendor and curriculum options.

The board discussed the recent bus mechanical issues and new bus options that were presented at a previous board meeting. There will be a new temporary bus driver until the end of the school year and a new, more permanent, bus driver will be hired for next school year. The board approved hiring a new special educator to fill a vacancy created by a teacher's retirement. The board also discussed some changes in the base rate at the state level that will affect Mt. Holly tax payers by reducing the tax rate by 5 cents.

The next meeting will be on May 7, 2014 at 7:00 p.m. at Mt. Holly Elementary School.

Parenting is a Word Game

From Bela Schug, your School-Community Liaison

As parents there are so many times when the way we choose our words can make a huge difference in the ways kids respond! Here are just a few:

Tell, Don't Ask- Ever catch yourself asking your kid, "Do you want to put your shoes on now?" That's not what you really meant, right? Because your kid could be absolutely within her rights to say "No, I don't want to", but it's time to go! Try this instead: "Time to put your shoes on."

Ask, Don't Tell- Okay, I know I just said, "tell, don't ask", but there is also a time to ask, and not tell. Our kids also need lots of chances to solve problems themselves- especially those problems that keep coming up over and over (arguments with siblings or friends, trouble getting ready in the morning, getting homework done, etc). When you have time (not when you are already late for the bus!), try asking your kid for ways to solve this problem and how to handle it next time it comes up. Then discuss which ones to try, give a good honest try and discuss how it went and whether any changes should be made. Your kid will be more invested in making these solutions work, will feel listened to, and will get practice solving problems.

Positive Language- This does not mean you are only talking about sunshine and rainbows! It means that you turn your language so that you tell a child what you want to see them do (not what you Don't Want). So, instead of "Don't run down the stairs!", you say, "Let's walk carefully on the stairs and hold the railing." People can't easily visualize "Don't" in their heads- if I say to you, "Don't open that door," you are likely to picture opening it! But if I use positive language, and say "Keep this door closed," you are more likely to see a closed door in your head.

Consider Readiness for Communication- We all have times when we are better listeners. When a person is upset, angry, hungry, tired, in a hurry, or busy with something, they just don't have the headspace to listen well. Add to that that kids are still developing communication skills, and a parent is put in the position of needing to consider the time and place to talk about something as well as how simple or complex our way of speaking should be for the situation. When you are dealing with a very upset child, try to keep your speech very simple, clear and short. If necessary, say' "We'll talk when you are calmer" and stay silent for a time, even if your kid is trying to talk to you (likely shooting his mouth off!). Wait until you both have a chance at listening and thinking while you talk, otherwise it's an exercise in frustration.

These word games can take some practice, but are worth a shot- I have seen great results for those who try! Next time, I will continue the discussion to talk about how to get the most out of praise and ways to offer choices to still get what you want while avoiding a power struggle.



Solar Satisfaction

How can you not love getting your monthly Green Mountain "bill" that always says they owe you money? Photovoltaic (PV) solar electricity generation works that way. We produce enough to sell some surplus. I even enjoy taking a break from yard work to watch my electric meter running backward on a sunny day. Nickel-dimenickel-dime, it all adds up. After we had our energy audit and completed some major weatherization work on the house in 2011 we took the next step towards energy independence. Since July 2012 we've had our PV panels collecting free sunshine, even on cloudy days, and turning it into electricity to power all our home needs. We have electric everything (stove, clothes dryer, water heater, refrigerator, this computer, etc.) and pay nothing for the electricity. Green Mountain actually owes us a little most months, which we accumulate in our account. The system was nicely designed to fit our property and meet our electrical needs. Thanks to federal and state incentives about one-third of the installation costs were covered. This makes great sense not only for our personal economics but also to transition from burning fossil fuels to a sustainable renewable energy based lifestyle that I believe must happen. 


NITKA'S NOTES FROM THE STATE HOUSE

The Transportation Bill, H-572 passed the Senate last week without a single "no" vote. Six-hundred sixty-six million is the amount of money budgeted for the period July 1, 2014 to June 30, 2015 if all goes as planned. It spends seven and one-half per cent or 15 million more for paving than in our current Fiscal Year. There is 71 million in the bill to be spent on bridges. Winter maintenance is always an issue and in an average year 20 million is allocated. Thus far this year, Jan 1 until now, we have already spent 28 million and could still spend more. Potholes are a separate matter and much worse this year than usual as we all know. There have been many dented rims and flattened tires as well as other front end issues as a result of them. The hot mix plants will soon be opening after being closed all winter and crews will be able to get material to fix them. Towns will be receiving 48 million in the upcoming budget year for their needs. As far as revenue for transportation coming in, we are 3 million behind the January forecast.

While you're driving around out there, take notice of our green and gold historic markers that are at notable places all around the state. One was unveiled at a ceremony inside the State House this week that will be placed surprisingly, in the state of Virginia. It will be the first time that a VT roadside marker will be placed beyond our borders. This year marks the 150th Anniversary of the Shenandoah Campaign of the Civil War including the Battle of Cedar Creek where the First VT Brigade and the 8th Regiment did remarkable service. The commemorative marker will be installed in October of this year at the site where Vermonters made a valiant effort to support the Union cause during the war. The language and funding for the marker were in last year's Capital Bill. The VT Division for Historic Preservation, Civil War historian Howard Coffin and Senator Joe Benning worked on this project as well as others.

The painting of this battle scene, done by Vermonter Julian Scott is housed in the State House. Scott, from Johnson, VT joined in the Civil War with his father. He was 14 or 15 at the time he entered as a drummer boy, allegedly lying about his age. He was one of the first persons to receive the Medal of Honor for rescuing fellow wounded soldiers at another battle. After the war he attended art school in NY City and returned to VT to paint many depictions of the war. Tax payer money at the time helped to finance the Cedar Creek painting as well as the large frame surrounding it. NITKA'S NOTES FROM THE STATE HOUSE

These are the days of Spring school trips. Children are "exploding" off of school buses onto the front lawn of the State House, having been sitting on the bus for long hauls to get to Montpelier. It's not easy to be quiet in the State House after a long trip and to listen to a tour guide talk about history and an old grey building but they are doing it almost every day here. One of the first things they do is try to find the many fossils that are in the marble floor in the entry way. If possible, students are introduced as a group to the members of the House of Representatives. They also get to hear from some of our 8th grade pages who are working at the State House. Many students are following certain bills and the older ones are preparing reports and interviewing legislators. They want their opinions on bills and why they might or might not vote

a certain way on a bill. Some issues in bills that were raised by students today as one passed them in the hallways were about: eyewitness identification involving a crime, food labeling, drunk driving penalties, requirements to work and serve alcohol and bullying consequences. They've been doing their homework and are ready with their questions.

Issues directly affecting children are topics undergoing study every day here. In addition to all the education bills that will affect our 89,000 students in grades K-12 are other bills such as H-581 re Guardianship of Minors. This bill was presented following a report by a study committee, comprised of parents, relatives of children, judges, social workers, lawyers and other interested parties who worked for almost two years to get consensus where ever possible on issues affecting children who needed guardians and to have it be in the best interests of the child. There are approximately 3000 children under guardianship in VT. Some are due to parents in the military and deployed overseas, incarcerations, substance abuse situations, mental illness, disabilities and deaths. The majority of guardianships are with relatives but many are with other parties. There are also financial guardians for some children as well. The bill spells out responsibilities in consensual and non-consensual arrangements, powers and duties of the guardian, etc. while keeping with the presumption that the interests of a minor child are best promoted in a child's own home if possible. This bill gives clear guidance and will hopefully reduce conflicts. It protects the rights of parents while addressing the best interest of the child. The bill is most likely to pass this month and become law on September 1, 2014.

MESSAGE FROM MONTPELIER

Legislative Report from Rep. Dennis Devereux for Ludlow, Mount Holly, and Shrewsbury

The House side of the Legislature has acted on the major tax and spending bills. The Misc. Tax and Property Tax Bills raised many fees and the education property tax rate. The increases in revenue were proposed by the Ways and Means Committee. Many fees are set to respond to the money required to administer through the Office of Professional regulation the many registered professions in our state. My areas of concern are the reduction in the Research and Development Tax Credit, and the large tax increase in e-cigarettes at the wholesale level. The Property Tax Rate Bill passed with a four-cent increase, which had been proposed to be as high as seven cents. It contains changes over several years to small school grants, the renter rebate program,

and creates a property tax appeals study. The bill would also require that one-third of any general fund surplus be committed to pay the health care obligation for retired teachers. The tax rate is adjusted to reflect the statewide spending on schools. The seven-cent increase was lower because spending went up by a lower amount than anticipated.

The big budget bill includes the money required to operate state government, fulfill our commitments in the areas of human resources, grants, and school funding. I hope to see some spending reductions, and lower the need to raise the necessary related taxes offered by the Senate side.

The bill to address the underfunded teacher pension fund is being considered. H.673 would begin to change how the retired teachers health care costs are being paid. The bill as proposed would increase the weekly contribution for non-vested and new teachers into the system from 5% to 6%. It would also require an annual assessment paid by the hiring school district for each new teacher. This amount would be set annually, but also needs to be paid each year. This is a real cause for concern as it would be placed on local school budgets and paid by the property tax. The assessment starting in 2015 has an estimated first-year cost of \$1,072. I have mentioned in previous articles that this underfunded obligation is a serious concern. The proposals in the bill were worked out by the State

Treasurer, Governor's Administration, School Boards Association, and the Vermont -

NEA and will not likely be changed. My understanding is this is an attempt to move some of their health care cost to the Education Fund. One question unknown at this point is whether moving to a single-payer system in 2017 would help address the problem.

On the lighter side, the Mount Holly mammoth tooth and tusk will become our state's official 'terrestrial fossil' with the signing of Fish and Wildlife Bill H.589. It was added as an amendment to the bill by Senator Alice Nitka. The Mount Holly Historical Museum

Board and our elementary school appreciate her action, and can now look forward to requesting a state historic site marker be erected near the site of where the fossils were discovered, when the last spike was driven to complete the railroad from Burlington to Boston, and our fossils being named our state's co-fossil along with the Charlotte whale.

SELECT BOARD ~ APRIL 08, 2014 - The meeting was called to order at 7:30pm by Jim Heald. Raymond Tarbell and Tim Martin were present. Jim welcomed everyone and requested that

speakers raise their hand to be recognized, state their name and keep remarks civil and short.

- 1. Additions/Deletions to the Agenda: Jim requested that the Other Business section be moved to the top of the agenda, to allow some folks to leave after their interests were discussed. There were no other changes.
- 2. The minutes of the regular meeting of March 11 were reviewed. There were no corrections or additions and upon motion made and seconded, the minutes were approved.
- 3. Other Business
 - Proposal to open Mount Holly roads to ATV travel

This item was tabled from the March meeting. Jim Heald read a letter from Paul Faenza, the constable, regarding this proposal. Paul noted that complaints he has received are not regarding people traveling from one property to another, but about folks racing on the roads, spinning their tires and tearing up adjoining land. He feels that if the town allows their use on all gravel roads, recreational ATV users will take this as permission to ride, regardless of any rules that may be established. He made several suggestions towards rules and noted any ordinance would need to have enforceable measures, to prevent recreational use on the roads. Jim opened the floor for comments.

Don Patch added several suggestions to his prior proposal, including opening only specific roads for specified months and hours. The roads would be sponsored by a 'committee' for the road, with a contact person for law enforcement to go to for help resolving problems. He suggested an annual application process and closing roads when problems are not resolved. There were comments pro and con having an ATV club in Mount Holly, and the statewide trail system in NH. The Board agreed to a committee to develop a set of rules for consideration at a later meeting. Don Patch, Bruce Turco, David?, Tim Martin and Fra DeVine committed to being on the committee.

Jim Heald read a letter from J. Brown regarding his water problems, as well as a letter from Master Plumbing regarding work that had been done at the Harlow house, which disagreed with some statements in J. Brown's letter. expense should be shared by the town and the beneficiares and that a written agreement be considered from this point forward. The Board tabled this, pending further information on solutions and costs and speaking with S. Craword re an agreement.

- 4. Highways

• Paving Grant and Structures Grant. The Paving Grant application was submitted, but the town is unlikely to get one this year. Jeff Teter also reported he had submitted a Structures Grant application for the 6'X9' multiplate culvert on Tarbelville Road, near Rte 155. This work requires a hydraulic study, which may not be done in time for this year. The town would likely get the grant next year if that is so. Jeff will also be meeting with Jaron Borge (ANR) to discuss stream alteration work on two other structures above the

- culvert, which could reduce costs from \$165,000 each for replacement to \$57,000 for the alteration work.
- Healdville Road 1970's curve issue. VLCT's response on this was read, and they concluded that since this is basically administrative cleanup of actions taken in the 70's, the town does not need a public hearing or require a public vote on the issue of turning over the old road land to the adjacent landowners. Paul Greineder noted that the town could go two ways to turn the land over: a quit-claim deed (which is the simpler) or work off a survey map he can provide. The Board agreed to contact S. Crawford for her input on how best to accomplish this.
- FEMA Update The State has forwarded the Town's request to de-obligate the funds/work for the Sawyer Hill Road culvert upgrade, with the State's endorsement of that plan.
- 2001 Truck. This truck needs to be replaced. The Board discussed replacing it with a tandem truck versus a six-wheel truck (as current). Jeff noted that many towns are moving to tandem trucks, which are larger and

Leave a phone number where Jim can call you back. Do not burn until you have spoken to him. SAFETY FIRST ALWAYS would enable the town to do some of the trucking of road materials from SLC itself. He had information from 6-7 vendors on truck pricing, and a tandem would cost about \$20,000 more. The Board did not make a decision on a make or vendor, but upon motion made and seconded, it was

VOTED: To purchase a tandem truck to replace the 2001 Truck.

Jim Heald noted that he is not convinced that doing our own trucking will really work, given our small staff. The decision of vendor and whether or not to keep the current plow and wing will be made later.

• New Garage.

Dave Josselyn, the contractor of choice, was present and looking for a green light to start on the work of the new garage. Dave Venter noted that he was meeting with the lawyer next day to complete the deed for the land. The Board agreed that Josselyn could move forward, pending the closing on the land. Upon motion made and seconded, it was

VOTED: To hire Fred Glover to complete the work needed for the closing on the town's behalf.

• Solar System

As part of the land transfer, the town agreed to spend \$35,000 on a solar system for a school curriculum program and also offset electricity costs of the school. There is currently a state grant program for schools and municipalities that could provide up to \$12,500 towards a system, but the money is going fast. Jeff presented two proposals for a 10-kW system and recommended the one from Same Sun in Rutland. This proposal is slightly less expensive and has a real-time monitoring system for the curriculum. The inverters for a system will need to be in the town office basement, as there is no room for them in the school's utility room. The size of the system will have to be revisited if the grant money is not available. Jim Heald will take the contract to Glover for his review.

- 5. Report of Treasurer
 - David Johnson presented an income and expense statement dated March 31, 2014 showing cash balances of \$1,934,360. There is about \$85,000 in outstanding delinquent property taxes on 40 properties, half of which have made partial payments. Solid waste label sales are down; this will be monitored vs tonnage. Zero-sort hauling will need to be done at 6 days rather than 8 days; this contributed to the compactor problem. Under cemetery expenses, it was noted that the branches are off the trees at the Tarbellville cemetery, but trunk removal will wait until after the snow melts.

• David noted that the bond application was in hand and would be completed shortly.

6. Transfer Station:

See comments under treasurer's report.

- 7. Planning Commission
 - The annual appointments for the Rutland Regional Planning Commission (RRPC) and the Rutland Regional Transportation Council (RRTC) are due for FY2015. Requests for Letters of Interest will be posted and put in the ChitChat.
 - Local Emergency Operations Plan (LEOP) Anna McGee presented the updated plan (corrections to name and contact info, and a new format) for the Board to sign. She will forward it on to RRPC. Upon motion made and seconded, it was VOTED: To approve the LEOP as presented.
- 8. School Mowing Two bids were received and opened by the Board. Upon motion made and seconded, it was
 - VOTED: To award the mowing contract to Chris Devereux for \$975.
- 9. Other Business
 - Ray Tarbell had been approached by a resident who had some car damage (oil pan) when he hit a bump near Dodge Road and requested the town pay for the damage. It was noted that this bump occurs every year and the person admitted he forgot to slow down. The Board took no action.
 - Dave Venter informed the Board that all local school boards have voted against H.883, the Reorganization of School Districts. This bill would require consolidation of school districts down to 30 districts, with a single budget and governance board.
 - Don Richardson reported that the RRTC meeting devoted much time to the discussion of a new lane and turning access at Routes 4 and 7 near the Green Mountain Plaza (Hannaford's) to accommodate tractor trailer units getting to the distributor behind the plaza. Also, VTrans will be asked to evaluate the condition of Route 155 for prioritization of planned work.
- 10. The Board reviewed and signed the March orders for payment.

AFFORDABLE HOUSING OPTIONS FOR SENIOR VERMONTERS

Spring is a popular time to think about moving. Several types of housing are available for Vermont Seniors who are thinking of moving into something more convenient and affordable. Most common is Senior Subsidized Housing where rent is not more than 1/3 of the household monthly income. To qualify for an apartment, one must be either disabled or age 62+, and have an income that does not exceed certain limits. Income limits vary from one apartment complex to another, based on regulations. There is no limit on savings or money made from selling a home, but interest income is counted as part of monthly income. There are often waiting lists of six months to 2 years for Senior Subsidized Housing. In order to increase one's chances of finding an opening when it's time to move, it is recommended that folks apply early and to several different complexes.

Other types of apartments for Seniors have either market rents or 'affordable' rents, with different or no income or age requirements.
