parking lot, so vehicles will not be able to get into the crossroads via Maple Hill. From Rte. 155 one can come up Tarbelville Rd. and from Rte. 103 one can come up Belmont Rd., or Healdville Rd.)

Another favorite activity of Cider Days is **voting** for your favorite photographs for the **2020 Mount Holly Calendar**, which will be taking place both Saturday and Sunday in the Community Room in the Library & Community Center. ARE WE A HAPPY COMMUNITY?

IT IS NOT GOOD FOR MAN, or woman to be alone. Isn't it great when new research, like a recent study out of Canada, confirms what the Bible says?

What makes you happy, outrageously happy? A great education? The perfect job? A huge salary? Happiness researchers McGill at recently interviewed 400,000 Canadians and discovered that what makes us really happy is belonging to a closeknit community-- one that regular church includes attendance. Isn't that how we're told we ought to live in the Bible?

These researchers found that folks who are members of strong communities-typically in rural areas-- are



eight times happier than those who live in cities. Factors in greater happiness include shorter commutes-- ie. more time with family, much lower housing costs (urbanites pay over 30% of their income on housing), more contact with friends and family and overall less stress over safety issues. That last one makes it harder to reach out to neighbors and can be downright dangerous. According to the Daily Mail, social isolation can "literally change the brain, flooding [it] with a chemical that fuels fear and aggression."

In contrast, rural residents indicate they feel a stronger sense of connection with their neighbors. They tend to be less transient, and more likely to attend church. Clearly, small towns and rural areas "are more conducive than cities to forming strong social bonds," writes Christopher Ingraham of the Washington Post. (That's often why people move here.)

Researchers refer to "community cohesion"-- that strong sense of community values and a willingness to impose those values on public space. It's generally found that crime is low in neighborhoods where people feel free to discipline neighborhood kids caught skipping school or scrawling graffiti on walls.

When we long for close community we echo the community enjoyed by God: God, the Father, God, the Son, and God, the Holy

Candidate's statement: Local Government and Education To the editor –

Thomas Jefferson told us that "government closest to the people serves the people best." It wouldn't make sense, though, for towns to conduct their own foreign policy, or to expect select boards to field world class military forces. We entrust these matters to our national government. In the same way, we assign fundamentally statewide issues to our representatives in Montpelier.

Other public concerns are best left to our local governments. Vermonters, for example, are supremely interested in their town's development and character. Yet state agencies exercise increasing jurisdiction over development, often leaving citizens and town governments all but excluded from the permitting process in their own towns.

No government service is closer to home than the education of a community's children. Yet here, too, through regulations and laws like Act 46, state officials have granted themselves ever broader authority to manage our schools.

The decision to maintain or close a school rightfully belongs to its community.

Despite substantial evidence to the contrary, state education officials claim consolidation will save money. But no agency works harder to control costs than local school boards, and the first thing the superintendent of a larger district does is hire assistant superintendents. Management from farther away is typically less effective, and public schools already suffer from too many theoretical experts too unfamiliar with real classrooms.

Consolidation is at best irrelevant and will likely extend our education decline. Education costs have increased not because schools have hired more classroom teachers, but because schools are compelled by circumstance and regulation to spend ever more time and resources delivering behavioral and social services. We need to address this diversion of resources and restore schools' academic mission. Weston Playhouse announces fall foliage production

The Weston Playhouse's 2018 season expands into the fall with *Two Trains Running* by Pulitzer Prize-winning playwright August Wilson at the company's new second stage, Weston Playhouse at Walker Farm, beginning September 27.

It's 1969, and urban planning threatens the demise of a popular lunch counter in Pittsburgh's close-knit Hill District. Owner Memphis struggles with whether or not to sell, and at what cost. Wilson's warm and personal portrait of a time of extraordinary challenge and change is Weston's 4th annual American Masters offering, featuring plays by iconic American playwrights in productions by artists of national standing.

Two Trains Running premiered at Yale Repertory Theatre in 1990 and moved to Broadway in 1992 in a production starring Laurence Fishburne. It is the seventh play in Wilson's Century Cycle, a collection of ten plays that depict African-American life throughout the twentieth century. The original production was nominated for four Tony Awards and was a finalist for the Pulitzer Prize for Drama. Wilson's best known work, *Fences*, was seen at Weston in 2003 and was made into a film in 2016 directed by and starring Denzel Washington.

Weston's *Two Trains Running* is led by director Reginald L. Douglas, Artistic Producer of City Theatre in Pittsburgh, whose work has been seen at Contemporary American Theatre Festival, McCarter Theatre, and the Eugene O'Neill Theater Center, among others. The creative team includes Scenic Designer Alexander Woodward (Williamstown, Dorset, Yale Rep), Costume Designer Sarita Fellows (NY Classical Theatre, New York Theatre Workshop, Juilliard), Lighting Designer Amith Chandrashaker (The Public Theater, Lincoln Center LCT3, The Flea), and Sound Designer Sinan Refik Zafar (New York Theatre Workshop, Berkeley Rep, Yale Rep). Production Stage Manager is Martin Lechner.

Response to Paul and Judy Nevin article in September ChitChat Art and Ida Gage

Paul and Judy Nevin felt it necessary to inform everyone that our "grievances" in this public manner were largely out of anger that last year Art and I had to abandon a lawsuit we initiated against the Foundation after the case proved groundless. It is hard to understand why Paul would do this because he did help us from start to finish. He has been a respected friend for 60 years. It did work as many questioned our honesty and reason for writing The "takeover" of Lake Ninevah.

1. March 27, 2017: Paul knows the Foundation charged us with encroachment starting the problem. Their Forester, Jim Roberts had poked around boundaries, checked pins, and surveys, read our deed and took an aerial picture of our property to confirm. They would let us keep land as is until we died and offered to pay half for survey. We were 80. Paul showed us a survey for our neighbors' property. It was done by Coleman surveyors (member of the Foundation) showing we owned their stonewall and brook. This survey was used by Forester and later by our surveyor (Rose). We were told many times the Foundation ran the lake and the town had no say. Paul told us the Foundation informed Selectmen. When we die they simply claim our property. He did not agree with the way they were handling it and neither did a town employee. Many problems with deeds at Ninevah surfaced when owners started surveying their properties The Blakelys were lax in filing deeds which did not coincide. The Foundation saw their chance to get control of our property. The Foundation purchased a large piece of property on the South side of lake which includes the lakefront from bog to their camp. It is highly restricted development available to members only. The town has no say on this piece of land as it is available to members of Foundation only. The State's current Use program is the Agricultural and Managed Forestland Value Program controls this. It appears to be 843 acres. The Foundation or State need to show the community this transaction and explain it.

2. August 31, 2015: We hire lawyer Chris Larson, a Vermonter. Our deed was worthless. Blakelys measured our 70' waterfront and on road placed j-bar near the brook on south and the far side of the maple tree on left (no measurements) there were 8 people present that day. All are deceased. Today our j-bars on the waterfront are still there. The j-bars by the road disappeared long ago. We found a matching j-bar several feet in front of our maple not by the corner of the camp where Foundation claimed our property line was. We were excited and showed it to Rose. He told us to leave it as it might help. Two weeks later when we returned it was gone. Probably someone just poking around. We planted a row of trees along our southern border (dead now) and left a large stump when electric company made us cut down maple tree to mark our boundaries. We never encroached. We studied Adverse Possession/Quiet Title and knew it was only chance to keep our property. We called the Rutland Court who said we had good chance after 58 years but advised us to hire a lawyer.

3. August 2015-May 2016: Lawyer Larson states it best to settle out of court so writes the Foundation. The reply back from Andy Schult (Vice President and lawyer for Foundation) rejected everything and said we "listened to a bunch of old men" and built wherever we pleased. The Foundation hired Robert Worthington. Our lawyer should have filed right away and saved us money. The letter exchange continued and only resulted in our lawyer "filling his pockets while emptying ours."

4. June 2016: our lawyer sues for Quiet Title. We got the complete file from the court and found out you have to sue to file your case. (Lawyer Schultz will say we sued the Foundation rather than we filed for Quiet Title.)

5. August 2016-Foundation files counterclaim. They use Rose survey never stamped or filed. "The Rose Survey confirmed the location of the boundary between the Ninevah Property and Gage Property (the Record Boundary) as described in the deeds of the Gage Property." (Our deed from northeast waterfront to northwest road reads:" It is ________feet to road (no coordinates). 'The Rose Survey confirms Ninevah's understanding of the location of the Record Boundary. Plaintiffs have refused to recognize the Record Boundary' The Foundation Forester confirmed a portion of our camp and wooden walkway was built on Ninevah Property and also claimed our shed and retaining wall was on Ninevah property. (No mention of Coleman survey he used paid for by the Foundation that was wrong. They cite that Ninevah Property is held for public and charitable purposes through their non-profit, tax exempt charitable organization. It has been 53 years and we knew nothing about their organization and the land was open for public use. We are charged with not recognizing boundaries and refusing to allow the Ninevah Foundation their rights to control use of their property which in turns denies the public they represent to use of the property. VERMONT SUPREME COURT DETERMINED PROPERTY HELD FOR CHARITABLE PURPOSES MANY BE SUBJECT TO CLAIMS OF ADVERSE POSSESSION UNLESS THE LAND IS DEDICATED UNCONDITIONALLY TO PUBLIC USE AND USE DIRECTLY BENEFITS AN INDEFINITE CLASS OF PERSONS. THE GAGE'S USE OF THE PROPERTY HAS BEEN EXCLUSIVE. No one has been on the land in 60 years because it is unusable. Many could easily prove it.

6. September 2016- We expected our lawyer to go after them but does not. We ask: "How can they file using an illegal survey. Answer: "Because they can!" We state: "They are bullying us." Answer: "Yes they are." He has a letter for us to sign: "The Gages will procure a final survey plat with a suitable description of the boundary line located at what is now shown as the "line of occupation" on the Rose draft plat. The Gages will prepare a quit-claim deed in favor of the Foundation relinquishing any rights to the property northerly of the boundary line". What happened to our slam dunk court case? We refused to sign and he yelled at us when we said we were hiring another surveyor. We fired him.

7. October 2016: Our lawyer petitioned the court to be released as our lawyer. His notes: Art charged him with filing a frivolous lawsuit, which is true. I had heart problem and he says my implanted defib went off when I read a letter he showed me. I have ICD and am hit by 350v of electricity. A 911 CALL is needed. We did not understand at first his reason for court but realized his records would look better with a release than being fired.

January 2017: We went to court. THE JUDGE SHOWED US A DISMISSAL OF ALL CLAIMS AND COUNTERCLAIMS AS PARTIES HAVE REACHED A TENTATIVE AGREEMENT AND HOPE TO REACH A FINAL RESOLUTION. IT WAS FILED AND SIGNED BY ROBERT WOOLINGTON, FOUNDATION LAWYER. Foundation dropped the case not us. We never had reached a tentative agreement with hope to reach a conclusion but we signed. We were elated because we got rid of our lawyer and the lawsuits. (Lawyer Schultz will tell you about our lawyer not want to represent us anymore but forget to tell you about the Foundation filing to Dismiss the lawsuit because it was illegal.).

8. February 2017-June 2017: (Lawyer Schultz also forgets to tell their lawyer was no longer representing the Foundation.) It is now Lawyer Schultz vs. us. We paid for new survey in November 2016. It showed our line was on our side of brook but measurements to north was 5' feet short of the Maple tree. It was not close to the large piece of land the Foundation claimed. We offered to buy it. Paul contacted Foundation. It would be \$500 plus closing costs. Mr. Shultz sends us a four-page affidavit which includes control of our property and paying for their lawyer in boundary dispute.

March 15, 2017: We decline and ask him to answer only if Foundation will sell.

March 28, 2017: Mr Schultz writes a scathing letter reiterating everything and concludes the Foundation will not sell the land at any price without reimbursement for legal expenses.(Lawyer Shultz will forget to tell you the Dismissal order signed by both parties agreed that each party was responsible for their own expenses in the dispute.)

June 19, 2017: Mr. Shultz asks why we did not answer his letter of March 28th. He encloses a lawsuit he is going to file against us. Robert Worthington Foundation lawyer suddenly reappeared to write it. I am just saying, it sounded a lot like it was from Lawyer Schultz. At least our legal survey was used. Just to let everyone know he would have to sue us to file the lawsuit. We tore down our retaining wall, tore up our cement foundation and moved our shed to the other side of our camp. We have documentation for all of this and will be more than happy to share with anyone, especially Lawyer Schultz's letters. We are \$30,000 plus poorer but still in full control of our property until their next attack. The Ninevah Foundation can now publish they own 3,300.00065 with a maple stump included. This is the Ninevah Foundation. A Foundation member went by the other day and commented our place looked like the public works department. He is a nice guy and don't think he ment to be mean but it stung. I get very angry when I see Art, 82, shoveling the heavy fill in 90 degree heat when at our age we should be enjoying the lake. Paul and Judy say we are angry? We do not act out of anger. We discovered a lot from our research and thought the local people should know what is happening. We welcome other opinions but not dishonest attacks that damage our reputations. We apologize to the readership of Chit Chat as the need to salvage our reputation should never have happened.

The Ninevah Foundation

Will somebody representing the Ninevah Foundation please tell me why, as a Mt. Holly resident and taxpayer I can't

go for a swim at Lake Ninevah? There is no "posted" public beach area that I', aware of. I've looked. So I'm reduced to sneaking onto "private property" and risking a fine (\$162.00) or a visit from the State Police, just for taking a swim on a hot afternoon!

All this talk about foundations, camps and organizations – what about the people who live here! The Foundation claims that it opens up nearly all of its land (3,300 acres) for various forms of outdoor recreation. If that's the case, then why are the <u>six</u> beaches owned and operated by The Foundation <u>clearly</u> <u>posted</u> as "PRIVATE" for their members and friends only? In other words we the taxpayers of Mt. Holly are not welcome! Why, at the very least, can't one of these beaches be opened up for the residents of Mt. Holly to enjoy? Are we not considered "friends" of The Foundation?

In case anybody is wondering "suitless swimming" is allowed on all <u>six</u> of these "private" beaches. In other words, <u>**nudity**</u> is alive and well at Lake Ninevah! <u>The</u> <u>**Dam**</u> and <u>**Sunset Beach**</u> are "referred" areas for this "nudist" activity.
