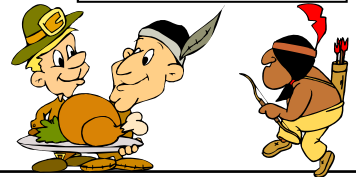

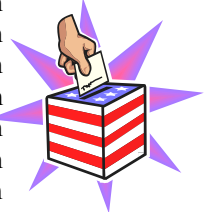

## BRACC UPDATE November 2012

The Black River Area Community Coalition (BRACC) is pleased to report that 9 pounds of unused or out of date pills and other drugs were turned in during Take Back Day on September 29. Thank you to all who took the opportunity to safely dispose of unwanted pills by taking them to the Ludlow Police Department or Rutland's Diamond Run Mall. The national program has grown steadily since it began in 2010. This fifth Take Back Day in 2 years is sponsored by the Drug Enforcement Agency. Watch for a similar event which will occur again in the spring.

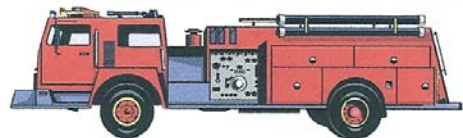
BRACC reminds adults to model healthy behavior in an effort to be better role models for your children, grandchildren, neighbors and friends. The most recent school culture survey shows many of our children at Black River High School who drink started drinking and/or smoking cigarettes before the age of 13. Of those who drink, 45% started by age 12 or younger. Of those who smoke cigarettes, 20% started by age 12 or younger.

In addition second hand smoke can be almost as unhealthy for children as smoking. Recent surveys show that 68% of our high school students were in the same room with someone who was smoking in the past 7 days. Second hand smoke is known to cause asthma and other breathing difficulties. If you smoke, you should never smoke in the car or inside your home with children present.

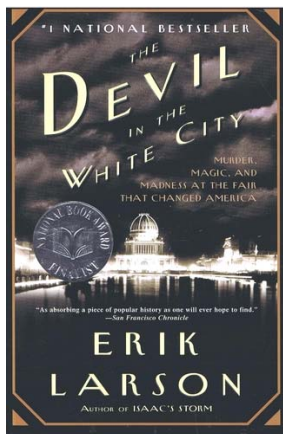

## Mt. Holly School Board Meeting

The Mt. Holly school board met on Wednesday, October 3 at the Ludlow Elementary School. Mr. Williams reported that the food service provider, Abbey Group, recently went through some major staffing changes and the food service committee has developed an improvement plan with them. He also reported that the elementary schools have received a healthy snack grant with which the students receive fresh fruits and vegetables in the afternoons. He also reported that the science NECAP scores are in and Mt. Holly's students are among the highest scorers in the state. Mr. Hutt Vater noted that the school scored 80% proficient on these tests when they took them last spring.

Andrea Sanford spoke about the importance of recognizing 11/11 as the Veterans Day holiday, not just an inservice day. Mr. Venter discussed some of the grant plans in the works with Green Mountain Power. The board also discussed working with the Lake Ninevah Association and with Southern Vermont Hydroponics on various projects. The board approved a mission/vision statement.

The next meeting regular meeting will be held on November 7 at Ludlow Elementary School at 7:00p.m.

### Local Issues Update by Rep. Dennis Devereux

Many have asked for an update concerning the Blue Spruce House Project. There has been little change since the church received a permit last June to renovate the block building in the back into an onsite contractor's residence. It is obvious that they are continuing to clean and paint the outside of the main building. Will Hunter and his group continue to have conversations with the Department of Corrections about using the site as a place for women coming out of prison to reconnect with their children. The Department has been adamant that they do not have a need for this type of facility in the area. I was informed that there is vacant space suitable for transitional housing in both the Springfield and Rutland area. Recently Rutland Mental Health and The Blue Spruce House submitted a proposal for a program for women in Mount Holly. A reviewing panel scored several proposals based on experience, programs and cost. The Department of Corrections stated the Vermont Achievement Center would provide the best opportunity.

There appears to be no progress on providing cell phone service in the near future. There has been no information from the telephone company to the property owner since the balloon test nearly two years ago. The Vermont Telecommunications Authority has no power to make any company provide service. I did receive a call from an assistant to the president of AT&T a while ago, and he was going to check for any activity in our area. It is very frustrating to see no movement whatsoever

after all this time. The telephone companies are able to decide where and when they will expand. We hear the rest of the state is moving toward total broadband coverage, yet we have no cell phone service. The governor stating that some parts of our state may not get complete coverage was not great news for our area.

### Justice Of The Peace - VOTE NOVEMBER 6th – VOTE FOR REPUBLICAN CANDIDATES

Justices of the Peace join other town officers to make up the Board of Civil Authority and Board of Abatement. We hear tax appeals, count ballots at each election, and perform tax abatements as needed. Justices of the Peace are authorized by the State of Vermont to perform Civil Marriage ceremonies.

**Re-Elect Diana Garrow** - A native of Mt. Holly the daughter of Dan & Shirley (Martin) Turco. Presently I serve as Assistant Treasurer of the Town of Mt. Holly since 1996 and have been a Justice of the Peace since 1992. In all those years I have not missed any elections and have counted ballots in Ludlow for Union #39 school district. I have sat in on many Tax appeals with the Board of Civil Authority and a number of Board of Abatement Appeals. I look forward to continue serving the folks of Mt. Holly in the future if I am re-elected.

**Re-Elect David Johnson** - I was asked to write something for the Chit Chat for Justice of the Peace candidates for this election. Although the political parties nominate candidates, the position is not (nor should it be) a political office. I think we have been fortunate in Mt. Holly that the justices have not gone about their duties with politics in mind and I certainly hope the voters continue to elect justices whose primary interest is to see that the job gets done, fairly.

Justices join other town officers to make up the Board of Civil Authority and Board of Abatement. I'm honored to have been a justice since 1992 and have never missed an election to count votes. On three different occasions, it was handy that I was at the Town Office to marry three couples. They had thought that the Town Clerk could marry them, but Clerk's only issue the license. I will look forward to serving again, if re-elected, in a non-partisan manner. Thank you, David H. Johnson

**Re-Elect Millicent Johnson** - life-time member of the community, daughter of Miles Richards, wife of James Johnson. Has served as JP for past 4 years. Worked in Health Care for over twenty years. Currently co-owns/operates Mt. Holly Feeds and Mt. Holly Dairy Aire Farm. Has served on the Mt. Holly Planning Commission since 2003.

## Mount Holly Town News

"The following minutes are considered 'draft' until approved, scheduled for the next Select Board meeting, September 11<sup>th</sup>, 2012."

SELECT BOARD, October 9, 2012 - Paul Nevin, Chairman, called the meeting to order at 7:30 pm. Raymond Tarbell and Jim Heald were present.

1. The minutes of the Regular Meeting of August 14, the Public Hearing minutes of September 19 and the Special Meeting of September 19 were reviewed. There were no corrections or additions and the minutes were approved.
2. Highways
  - Paving Grant. No word back from the State on the Change of Scope.
  - FEMA Update. No work back from the State on the extensions requested.
  - Irene-related State covered projects: The Town received payment for the Belmont Rd. bridge work.
  - Narrowband radio equipment has all been installed and appears to work better than expected, with less interference than the lowband. The lowband base and two radios have been kept in the dump trucks (enables talking to Ludlow). The narrowband means the road crew can contact Shrewsbury and Fire Dept. The school has contacted Allen Radio regarding their upgrade.
  - Loader: one of the teeth on the flywheel is broken, with an estimate of \$5000 or less to replace it. Jeff noted that we could keep a starter on hand (\$800) to keep it going if it dies unexpectedly. This is a critical piece of equipment in the winter. Upon motion made and seconded, it was

the Casella bill appears to show charges for processing the zero-sort. Paul noted that towns will only receive money back when the recycling is over \$80 per ton (a call to Casella noted that 12.33 tons were processed at \$65.72 per ton, with a resulting charge of \$176.) David also noted that the total spent on paving was \$230,464. Otherwise expenses are in line with the budget.

- The Board requested that solid waste expenses be tracked closely so we can compare with prior years. The gauge on the new compactor (recycling) will help determine when it needs to be hauled. Also looking at hauling the old compactor (trash) less often. As we gain more experience under the new system, this should bring down expenses. No monies/report on recycling revenue has come back to the town as yet; Paul will call them.
  - External Audit: The Board received 5 responses on the RFP for the external audit, with costs ranging from \$6,500 to \$19,000. The Board had a concern regarding how much information the town would need to provide electronically (beyond a copy of the QuickBooks file). Pending a satisfactory answer to that, upon motion made and seconded, it was
- VOTED: To approve hiring Jeffrey Bradley CPA of Rutland to conduct the external audit for FY12.
4. Solid Waste:
    - Disposition of Containers. – The town has two extra open (non-partitioned) containers at the transfer station, intended to provide overflow backup. There has been some confusion by Casella on what was supposed to be pulled. Paul will contact Casella about that.
    - The Transfer Station price list review is postponed until the next meeting.

    - Act 250 permit application regarding replacement of a GMP line on Route 103, Hortonville Rd, Cole Rd, and packer Rd.
    - Letter from Kulig & Sullivan, attorney for C. Prescott

Paul Nevin read the letter, which indicated that Ms. Prescott had been denied due process in the matter of removal of the dog 'Stuart' from the town, as the Select Board had not followed the Town Dog Ordinance. The letter requests that the Board rescind its order dated September 20, 2012 and either follow the proper procedures so that Ms. Prescott knows the allegations against the dog or order that 'Stuart' be confined in a securely closed and locked pen with a warning sign.

Ms. Prescott was present at the meeting. The Board noted that Section 3 of the dog ordinance states that a complaint about a dog who bites may be investigated by the Select Board and the Board may order that the dog may be removed from town limits. Ms. Prescott stated that she was confused by the process in the dog ordinance and accountability to the process. She stated she recognized that this has been difficult for all: the Select Board, the community, her family.

There was much discussion about the process, the clarity of the dog ordinance, notification of information regarding accusations and responsibility for the safety of the people of the Town. The Board is willing to talk to the town attorney regarding the ordinance and the process, but the bottom line was for the safety of the people of the town.

8. The Board reviewed and signed the September orders for payment.

9. The Board adjourned at 8:27 pm to Executive Session to discuss a matter from Vermont State Police. The Board returned from Executive Session at 8:34 pm.

This summer the staff at the Foley Cancer Center hosted a visit from their youngest donor, Myles Tristan Donohue, who delivered a check in the amount of \$320. What makes his donation so unique? It is the birthday gift request Myles made of the guests who attended his 5<sup>th</sup> Birthday party and celebration at Milky Way Organic Farm in Ira, VT this May. Seven years ago Myles' father Joseph, a local chiropractor, (who – given the nature of his profession – has always held health, wellness and vitality in high esteem); was diagnosed with Liposarcoma, (a malignant tumor that arises in fat cells in deep tissues such as inside the thigh or in the abdominal cavity). Joseph's tumor was found in the medial aspect of his left thigh.

Excitedly, when it came time to plan his first party that included invitations, Myles and his family decided to make a difference by encouraging his party guests to make a handmade card and bring a donation to the Foley Cancer Center instead of bringing a traditional birthday gift.

Viewing the bigger picture, around the 'intense gift' their

family was given, Lisa Donohue, suggested to Myles, "that while it's often fun and exciting to accumulate toys and other items, it's just stuff, Myles. Let's make a difference by giving back to Rutland Regional, and Myles gladly agreed to it.

Even though Joseph's bout with cancer occurred before Myles was born, his good health today is a result of the exceptional care provided throughout his varied treatment experiences. The Donohue's are very grateful to have the Foley Cancer Center nearby and that Rutland Regional is their area hospital. Community awareness and support is vital to embracing a diagnosis such as cancer, and in learning about prevention. Thus, when planning Myles' birthday party Lisa decided his event would combine the celebration of Myles' 5th birthday along with, (on a personal family note), Joe being a 7 year cancer survivor, post 2 important marker timeframes. It was the perfect opportunity for her family to say thank you for all the assistance and care they received from the Foley Cancer Center; and to quietly reflect on their efforts over the years, to support others in a similar realm, through their center, dedicated community volunteerism and ongoing fundraising. They invited family and friends to share this very special day with them. The farm was the perfect venue for the gathering. Donohue states, "It's never an 'I' in this life, but a 'We'. Myles' parents wanted him to have the experience of personally giving the envelope to the Foley Cancer Center, so a call was placed to Community & Provider Relations at Rutland Regional.

Since Myles has been a baby, he has known the rigors of Joe's needed care which included going back and forth to Boston in one day with his parents. Now as a 5 year old, Myles has developed a level of awareness around his Dad's incision and asks lots of questions about, "What happened to my Daddy?" During Myles' visit to the Foley Cancer Center, close to 30 Rutland Regional staff was in attendance. He enjoyed the starry ceiling and seeing how some of the new treatment equipment moved; not to mention offering raffle prizes to the attendees and his signage, balloon, and bag of goodies! Myles said all on his own, before entering the hospital that day, "Thanks, Mom for hooking me up with this opportunity." Joseph, Lisa and Dr. Lovett reminisced about "Dr. Joe's" five weeks of treatment and what became "afternoon rituals" at the Foley Cancer Center.

After a day of skiing, Joe Donohue noticed a lump in his upper left leg and knew it was not related to his activity on the mountain. Based on a personal history of Lipomas (a benign growth), as well as, various and trusted complementary modalities (that the family continues to utilize on a regular basis today) alone not offering marked improvements; his wife Lisa encouraged Joseph to see their family's Nurse Practitioner, Wende Morgan and Primary Care Physician, (at the time) Dr. Charles Egbert, who recommended an MRI. The image captured in the MRI lead Joe to consult with surgeons Dr. Bagley and Dr. Conway regarding a biopsy. The practitioners determined the need and sought orthopaedic surgeon, Dr. Boynton to confirm whether or not Joe had a soft tissue lump. When the consultations and review were complete here in Rutland, the conclusion was that he needed a frozen tissue biopsy procedure as soon as possible. To have this procedure, Joe and Lisa traveled to a specialist at Massachusetts General Hospital Cancer Center (MGHCC) in Boston.

Once the results were back and it was confirmed that Joseph's tumor was malignant, treatment options became the primary focus. The tumor was self-contained and would require 5 weeks of radiation before it could be surgically removed. Because of the commitment to quality care the Foley Cancer Center is known for, Joseph and Lisa felt very fortunate, "lucky" even, to have such a treatment facility so close and convenient to home. The couple stated that, "At this emotionally charged time, committing to 5 weeks of out of state for radiation treatments, would have raised the level of stress, personal costs, and burdens upon us; and may have flattened outright, our growing small business, the Thrive Center of the Green Mountains." Joe became a patient of the Center where his treatments and care were overseen by Dr. Lovett. Wife Lisa recalls being comforted by the doctor's name alone "You got to Love it" and states, "We have been very impressed ever since our first meeting". Joe returned to MGHCC for the surgery, on the chosen date of June 22, 2005; and after completing all required follow up and self care continues to live a very full life. He is grateful for the rock he has had in Lisa, as well as, support from other family members and friends.

Seven years later, with this experience behind them, the Donohue family considers themselves "lucky on the other side." Luck being defined as, "When opportunity meets both experience and preparation." When he was asked by Mom Lisa, after Myles delivered the donation, "What did you think you accomplished Myles? He said, "Helped someone else survive."
