


In Texas, she was the head of security in a mall for several years. She was a member of American Legion Post 52.



A big "THANK YOU" to everyone who donated a basket and helped out at Cider Days last weekend.



The Vermont Agency of Education is charged with monitoring implementation by schools of the Education Quality Standards which were approved by the Board of Education in 2014. The process consists of an Annual Review of each school and an Integrated Field Review (IFR) for each Supervisory Union every three years. Two Rivers Supervisory Union is scheduled for a field review on Tuesday, Nov 14. A team of educators from neighboring Supervisory Unions will visit our schools on that day to conduct our review. ## Wonder: Involuntary Praise

"**Don't you think the foliage is a bit dull this year?**" Have you heard anyone complaining about the colors this fall? I spoke with my blind cousin, Jay, today and he would give anything to be able to *see* colors...dull or otherwise. On a a recent flight, the attendant read a long list of arrival information as if she were reading it for the thousandth time that day --no emotion or interest as she droned on during our descent. Then, with that same tired, disinterested voice, she finished with, "Have a wonderful day."



She said "wonderful" but in a manner completely devoid of any sense of wonder. It *is* such an easy sense to lose.

Einstein said, "There are only two ways to live your life: One is as tho' nothing is a miracle: the other is as tho' everything is. The most beautiful emotion we can experience is the mysterious. It is the source of all true art and science. He to whom this emotion is a stranger, who can no longer wonder and stand rapt in awe, is as good as dead, a snuffed out candle:" If what Einstein said is true, then many people are snuffed out candles.

If a child is to keep alive his inborn sense of wonder, he needs the companionship of at least one adult who can share it, rediscovering with him the joy, excitement and mystery of the wonderful world we live in.

I still recall the day my 8th grade science teacher, Mr. Girth, showed up one day with a prism. It transformed the sunlight coming through the classroom windows

into dazzling spears of rainbow colors that danced around the room midst murmurs of awe. He said to us, "Today you've just learned the most important thing I can ever teach you and that is the ability to say '*Wow*!'" Moms are usually the ones who initially help us to make wonder a part of our early vocabulary: "Listen! Watch! Oh, come feel the bird's nest!" Our time here on God's glorious earth (*What a Wonderful World*) is too brief *not* to appreciate it by living life with wonder, passion, and emphasis! You and I ought to be bending as many moments as we can in life into exclamation points!

I understand that the Great Northern, that train that snakes its way through the Rockies, (some of the most spectacular scenery in all the world), got some complaints. One conductor stated, "We got so many complaints that there wasn't anything to do on this train that we had to install a TV in the observation car." *Really*? If you lose your sense of wonder then you have a hard time enjoying life and thanking God for all of its blessings.

Sometimes I fear that we approach our relationship with God like that flight attendant: Routine. Bored. Apathetic. Disinterested. Consider this: through Christ, we have the privilege of being adopted into the forever family of the living God, yet

often there seems to be little of the sense of wonder that ought to accompany that remarkable reality.

In the oldest book of the Bible, Job questioned God about his suffering, but when challenged by Him, Job was humbled by the wonder of his Creator and His creation. (Much like Vermonter "Snowflake" Bentley who never lost his childhood awe of "the treasures of the snow"-Job 38:22). Job replied, "You asked, "Who is this that obscures My counsel without knowledge?" Surely I spoke of things I did not understand, things too wonderful for me to know."

I long for the wonder of God to take hold of my heart. Adopted *by God* -- what a wonderful reality!

In Geography class, the teacher had asked the students to list what they considered to be the Seven Wonders of the World. One quiet girl said she was having trouble because "there are so many." The teacher suggested she read what she had. Hesitantly, she got to her feet and read, "I think the Seven Wonders of the World are to touch, to taste, to see and to hear..." She hesitated, "and then to run and to laugh and to love." (Brilliant girl!) So what are *yours? Pastor Glenn*

Select board meeting October 10, 2017 ~ the meeting was called to order at 7:30 PM by Ted Crawford, chair. Members

present included Tim Martin and Ron Tarbell. All stood to recite the Pledge of Allegiance. Minutes were presented from the regular meeting of September 12, 2017 with the following corrections: The Transfer station will begin fall/winter hours starting Saturday September 30, 2017. Hours will be Saturday's 8:00 AM to 2:00 PM and Sunday's from 8:00 AM to Noon.

Regular Select Board meetings are held on the second Tuesday of the month at 7:30pm in the Town Office. Items to be included on the Agenda are due by Noon the Thursday before the meeting.

Additions and changes included to the Agenda included one response to the Auditor's open position, a statement about solar power in Mt. Holly, and an update on the Sharon Lane septic system concern. The board received one letter of interest for the open Auditor position.

With her years of experience as auditor in the past and current work with the Lister's office, a motion was made and seconded to appoint Jennifer to the remaining term ending 2019. (3-0)

**HIGHWAYS** ~ this year's project for hydro-logically connected municipal Roads in Mount Holly is complete. There is more work to be done on other Town roads and we are hopeful that grant money will continue to be available.

Jeff reports that currently the rates for equipment usage are lower than FEMA sets. A discussion occurred and motion was made to increase equipment rates to meet FEMA standards. (3-0)

Discussion occurred about the winter salt bid provided. The bid comes in at \$68.68 per ton, which is an \$11.00 decrease per ton from last year.

**REPORT OF TREASURER** ~ David Johnson presented the board with an income and expense statement as of September 30, 2017. It is estimated that 81% of property taxes are in at this time. The Casella bill is showing that the there is an increase of approximately 7 tons as compared to last year. The Zero sort is also showing an increase of almost 2 tons.

The Lister's will bring a proposal to the board with an offer by the State to create a new property line mapping program. A sample map was presented to the board. The maps are parcel maps vs. Ariel maps. A discussion occurred and it was thought that a proposal will be brought to the board in the near future

## WARNING SPECIAL SCHOOL DISTRICT MEETING LUDLOW TOWN SCHOOL DISTRICT

The legal voters of the Ludlow Town School District are hereby warned and notified to meet at the Ludlow Town Hall in said Town of Ludlow on Tuesday, November 28, 2017, between the hours of 10:00 AM, at which time the polls will open, and 7:00 PM, at which time the polls will close, to vote by Australian ballot on the following articles:

**Article I:** Shall the Ludlow Town School District, which the State Board of Education has found necessary to include in the proposed unified union school district, join with the Mount Holly Town School District and the Black River Union School District #39, which the State Board of Education has found necessary to include in the proposed unified union school district, for the purpose of forming a unified union school district to be named the Ludlow-Mount Holly Unified Union School District (hereinafter the "New Unified Union District"), as provided in Title 16, Vermont Statutes Annotated, upon the following conditions and agreements.

- (a) Grades. The New Unified Union District will offer and operate pre- kindergarten through grade six education to students. The New Unified Union District will also operate Black River High School Middle School until no later than June 30, 2020. The School Board for the New Unified Union District shall determine the timeline for closing Black River High School Middle School. After the New Unified Union District has ceased operating Black River High School Middle School, it will pay tuition in accordance with the law to provide for the education of students in grades seven through twelve.
- (b) **Board of School Directors.** The New Unified Union Board of School Directors shall be composed of eight (8) directors. Membership on the New Unified Union Board of School Directors is apportioned to each town in equal numbers: Ludlow four (4) directors and Mount Holly four

Directors shall be nominated from the legal voters of each respective town and shall be elected on an at-large basis by the voters of the New Unified Union District.
- (c) Assumption of debts, ownership and closing of school property. The New Unified Union District shall assume the indebtedness of member districts and assume all operating deficits and/or surpluses or reserve funds of the member districts; acquire and pay for the school properties of member districts; all as specifically identified and provided for in Articles 6 and 7 in the Final Report. The New Unified Union Board of School Directors shall not close or discontinue any elementary school within its boundaries without a unanimous vote of the school board and an affirmative vote of the town in which the elementary school is located.



## Ludlow Group Explores an Independent Black River High School High School's Closure Could Open the Door for an Independent Town Academy

This week, a group of Ludlow and Mount Holly residents will begin the application process for establishing an independent high school in Ludlow. The group plans to submit a proposal to the Vermont Board of Education. The group's formation has been one of the results of a lengthy Act 46 process in both Ludlow and Mount Holly. Act 46 seeks to improve equity and expand opportunity in education for all students in Vermont.

The group held an exploratory public forum on September 14th to determine the feasibility of transitioning the public high school to an independent high school. The meeting had a good turnout with nearly 40 community members as well as teachers in attendance. The central theme of the meeting was clear: residents are passionate about educating the children of Ludlow and Mount Holly locally.

Momentum behind a plan for privatizing the local high school comes at a critical time. The Ludlow and Mount Holly school

boards recently voted to propose a new plan in response to Act 46. Under the new plan, both towns will maintain public elementary schools governed under a merged board and offer 7-12 high school choice. Black River High School would close and could re-open as an independent school. Both towns vote on the proposed plan on November 28<sup>th</sup>.

"The hope would be that an independent Black River High School would become a niche school and that it would be a draw for people from other communities. We have so many local resources to tap into and so many of the teachers are already doing great work in outdoor education and proficiency-based learning. We really believe we can build off of that and that going independent will give us the flexibility we need to keep educating our kids locally." - Melissa Perrino

The Black River Independent School would be an independent high school with a public mission. Education would be available free of charge to high-school students who reside in Ludlow and Mount Holly as well as interested students from other towns.

A weekly meeting will be held every Tuesday from 6-8 p.m. at the Ludlow Community Center until the vote on November 28<sup>th</sup>. Anyone with interest or expertise is encouraged to attend the meetings and to contribute to the work in progress. The group's primary focus will be to define a mission and vision for the independent school. Marketing, publicity and fundraising will also be discussed.



For some, an independent school looks enticing because certified teachers are not required and salaries can be less. That isn't conducive to keeping current teachers from leaving, and without certified teachers, how does this new school entice folks who want a solid education for their children? Having an independent school is certainly worth exploring, but it needs to be developed completely before the current high school is dissolved.

The school tax rate appears to decrease when there is no local high school, but much of that decrease is the removal of transportation costs. The taxpayer with no school-age children may save money, but those students still have to get to a school so the transportation cost is borne by their parents. This impacts lower income families disproportionately. Much of our strength as a nation has been built on a free education. When we make it harder for some to get that education, we are changing that basic premise.

Apparently there is no other Life Skills special education class in near-by districts. The number of profoundly disabled students who require this type of education varies from year to year, but if Black River HS is closed such a class would still have to be found for them. If that class is far away, the district can be responsible for paying for the student's board as well as tuition. This could deplete any expected tax break.

Not only does local control go out the window, but closing a school guarantees an economic decline for that community. Ludlow would probably feel that decline more than Mount Holly.

Black River High School thinks in terms of *our* students. The high school sees Mount Holly and Ludlow as one community. The question will be, does Mount Holly see itself as a part of that community. Carol Ballou

### Dear Neighbor,

As a candidate for a contested seat on the board of the potentially new school district, I have been asked by friends to write a short autobiography. I was born in Springfield, Illinois in 1977. I moved to Reading, VT in 1989 and attended Middle School in Woodstock. I then boarded at Phillips Academy in Andover, Massachusetts. I studied Mandarin in Colorado, lived in Beijing, dropped out of college and spent six years working construction (including, notably, four-months of carpentry at South Pole Station, Antarctica). I returned to and graduated from the University of Illinois in the winter of 2001. It was a surreal time, you may recall, so I packed a bag and bummed around Eastern Europe for a few months. I repatriated to Ludlow, worked at A State of Bean, and then Java Baba's where I met my future wife, Amanda. We moved into a cabin off the grid here Mount Holly and I worked for a year as a paraeducator at the Mount Holly School. Amanda and I then moved to Madison, Wisconsin for graduate school (Literary Studies for me and Curriculum and Education for her). In 2008, she was hired to teach science at Springfield High School, I won a research fellowship at Dartmouth, and we started a family. ## INFORMATIONAL HEARINGS AND MEETINGS

Mount Holly and Ludlow will have a second Act 46 vote on November 28. In essence, the proposed merger combines (but does not close) the two elementary schools, closes Black River High School Middle School (by June 30, 2020), and thereafter provides open middle and high school choice. Given the looming Act 46 deadline, voters will choose eight new board members for the hypothetical "Ludlow-Mount Holly Unified Union School District" at the same time that they either approve or reject the proposal. Four of the board seats are reserved for Mount Holly residents and four are reserved for Ludlow residents. Residents in both towns get to vote on all the candidates. This is called "at-large" voting. If the proposal is rejected in either town, the votes for the board members become irrelevant. If the proposal passes in both towns, all future school district votes for budgets and board members will be commingled between the two towns.

The proposed merger has its pros and cons and I encourage those with curiosity or questions to attend any or all of the four informational meetings to be held over the coming weeks.
