SELECT BOARD ~ NOVEMBER 15, 2016 - The

meeting was called to order at 7:30pm by Ted Crawford, chair. Ray Tarbell and Tim Martin were present. All stood and recited the Pledge of

Allegiance.

1. Additions/Deletions to the Agenda: There were several additions: under Highway, a letter regarding an issue between neighbors; under Treasurer's Report, a social services agency issue; and issues with the Selectboard computer, which were discussed immediately.

The Selectboard laptop computer was purchased in January 2011 and upgraded to Windows 10 during the summer. Since then, most Windows 10 updates resulted in the laptop not booting up properly. Larry Gold of EZ Computers said that really, computers from before TOWN OF MOUNT HOLLY

2013 are not compatible (drivers for video, printer, etc.) even though Windows 10 said they were. He recommended replacing the computer. Ted Crawford approved the purchase. The new computer should arrive by next week.

2. Minutes:

Regular Select Board meetings are held on the second Tuesday of the month at 7:30pm in the Town Office. Items to be included on the Agenda are due by Noon the Thursday before the meeting.

- The minutes of the regular meeting of October 11, 2016 were sent out before the meeting for review. Upon motion made and seconded it was VOTED: To approve the October 13 minutes. (3-0)
- 3. Highways
 - Jeff is on vacation, but sent an email to advise that the paving projects are done except for the store. Also the Odd Fellows Hall area was not done correctly, so they will be coming back for that. David noted that the paving will not get done this year, as the asphalt plant has shut down. Jeff

also noted that there was no report from the RRPC Transportation Council (TAC) and suggested that TAC be removed from the agenda unless there is a specific need. Jeff also suggested removing the Transfer Station as a regular item on the agenda (although there is an issue this month).

- A letter was received from a property owner concerned about vehicles and debris on a neighbor's property, including a • new driveway access. The property owner is building a new structure (garage?), although there is no building registration form. A highway access permit is up at the garage awaiting Jeff's approval. Ted drove by the property, but did not see anything out of the ordinary. One or both of the other selectmen will also view the property before responding to the letter.
- 4. Report of Treasurer
 - David Johnson presented an income and expense statement dated October 31, 2016 showing cash balances of \$3,518,882. Highlights: Property taxes received total \$4,067,000. Delinquent property taxes total \$223,677 on 103 properties (about the same as last year). Taxes were received late for 7 properties and 7 additional properties

paid before the information was turned over to the tax collector. All have been penalized and interest accrued. The Town received the 2nd quarter State aid payment. Solid waste (SW) labels sold thru October 18; some recycling income was received. Otherwise, not much to report.

- A social service agency (Child First Advocacy Center) was included on the warrant, but was inadvertently left off the ballot. The requested amount (\$400) was included in the tax rate. Upon motion made and seconded, it was VOTED: To pay the \$400 and include the agency as a new item on this year's warrant and ballot. (3-0)
- External Audit: David has reported that this is underway; he is trying to schedule an appointment for the auditor to come • and get fire and rescue information and some additional town information.
- Okemo Valley Chamber of Commerce: During last month's discussion it was mentioned that the dental benefits might be of value to the Town. Research shows that the benefits we currently have thru VLCT are slightly richer and cheaper as well. Upon motion made and seconded, it was VOTED: To not join the Chamber at this time. (3-0)
- Transfer Station 5.
 - The Town received a letter from the State (DEC-Waste Mgmt and Protection). On November 08, they conducted a site visit and found that there were a number of bags of trash on the ground and not in the compactor. The bags had been ripped open by birds and other 'vectors'. The Town has to correct the problem and respond to the State by November 16. The compactor was apparently full over the weekend, but it was not clear why the extra trash had not been put in the

spare containers on the site. Rhonda will call the State and let them know that it has been cleaned up and determine if a written response is required.

- 6. Insurance
 - Health Insurance: The Board has provided premium support up to the amount of the platinum plan offered by BCBS. Employees may select any plan on the Exchange, as they wish. Upon motion made and seconded, it was

VOTED: To continue to provide premium support up to the level of the BCBS Platinum Plan. (3-0)

- Health Reimbursement Account (HRA): The total out-of-pocket limit
 - on the health insurance has been raised to \$1300. It was suggested that the Board raise the HRA limit from the current \$1200 to that amount. Upon motion made and seconded, it was VOTED: To continue to provide the HRA, raising the limit to \$1300. (3-0)
- Rhonda will complete the necessary forms for continuing both the insurance and HRA plans.
- 7. Planning Commission
 - Rutland Regional Planning Commission (RRPC): Bill McGrath was not present, but sent an email with his report, which Ted read. A speaker from the VT Dept of Health spoke of the new 3-4-50 program to improve the health of Vermonters by each town building walking and bike trails. When asked if there was money for this from the State, she said no. The City of Rutland has started a new series of ads to attract people to the city. Mr. Alldaire stated they were going to ask every town to contribute to the fund, which has a

every town to contribute to the fund, which has a budget of \$200,000. The Town has not seen anything on this yet.

- Rutland Regional Transportation Advisory Council (TAC): Jeff emailed that there was nothing pertaining to Mount Holly at the RRTC meeting (see above).
- Planning Commission Vacancy: There is one term expiring this month and there has been one interested party for the position. Upon motion made and

seconded, it was

VOTED: To appoint Peter Berger to a three year term, expiring November 2019. (3-0)

- 8. Other Business
 - ATV Ordinance: Tim Martin handed out copies of a proposed ATV Ordinance for the Selectboard to consider at the December meeting. The Board requested that the proposed ordinance by published on the Newsflash and Chit Chat. They will be part of the minutes as well. Tim noted that there were a lot of changes from the previous version. This one is more like the Town of Benson's, with emphasis on agricultural use and leniency for ag users.

Fra Devine noted that the advisory survey settled the issue, with a majority against it. Tim stated that he gets calls asking when this will be allowed and he wants to do what the constituents are asking about. Ted noted that the survey was not a binding vote, and that some people said they were not offered one. Further discussion was delayed until next meeting; hopefully more people on both sides will come to the meeting.

• Auditors: The Auditors met and reviewed our town report and compared it with other towns. They are trying to get the size of the book down to save on printing and postage. They particularly liked the Danby town report contents and size. They have suggested the elimination of the following items: 1) the social services reports (20 pages); a few copies can be made available at the town office 2) community reports, except for the Chit Chat and Library (8 pages); ask those two to condense their report and put both on one page 3) schedule of compensation (1 page); it's in the budget as well; 4) dog licenses (1 page); 5) Haz mat (1-2 pages); 6) combine animal and constable to 1 page; or just put in the Chit Chat; 7)fire (rescue?) and auxiliary report, but keep the budget; 8) listers and planning commission combine on one page; 9) delinquent tax can be combined on next page.

The auditors also suggested that the book be mailed only to those that want it (about 100 people said they wanted it in response to the postcard last year) and we could drastically cut the 550 we currently print. Or we could not mail any and just notify people that the books will be available at the town office. Sue Covalla expressed concerns that the budget needs to go to all voters. She reviews the voter list and consolidates households so only one is sent per household. David noted that if the town report is not sent, the entire warrant is required to be published (Rutland Herald). Ted noted that there are 6 requirements in the Statutes that must be included.

The cost to print and publish is \$3775 for 2016 (600 printed, 495 mailed); \$3020 for 2015 (525 printed, 506 mailed). There seems to be consensus to reduce the pages. The Board requested that the Auditors suggestions be published so people can comment on them. The Board will make final decisions at the December meeting for narrowing it down, but still mailed out.

• Municipal Action Papers: Ted wanted everyone to know that VT League of Cities and Towns (VLCT) have issued 6 topics which include VLCT's position for legislative action. Topics include municipal self-governance, transportation,

land use and energy, public safety, taxation and budgets, and water quality. All of the papers can be accessed via from the homepage of VLCT's website: <u>vlct.org</u>.

9. The Board reviewed and signed the October orders for payment.

Town Of Mount Holly Ordinance All-Terrain Vehicle Regulations PROPOSED

Authority

Under the authority granted in Vermont Title 24 V.S.A. Chapter 59, 24 V.S.A Section 2291 (4) and Vermont Title 23 V.S.A. Chapter 31, Section 3510, the Select Board of the Town of Mount Holly hereby adopts the following civil ordinance regulating the time, manner and location of operation of all-terrain vehicles within the town. This ordinance and accompanying regulations are adopted as a supplement to and not a substitute for any Vermont statutes and regulations pertaining to all-terrain vehicles.

Purpose

The purpose of this ordinance is to allow Mount Holly residents, landowners, and their guests, who have the appropriate permission to travel on private land, limited approval for their all-terrain vehicles to travel on identified and approved town highways (or sections of highways), to connect to other private property, while protecting the health and safety of all vehicle operators, residents, animals, property and the environment.

Definitions

This ordinance will adopt the definitions of "All-Terrain Vehicle" or "ATV" and "Operate" as defined in Vermont Title 23 V.S.A. Chapter 31 section 3501.

"Active Farming" is to be defined as anyone engaging in the cultivation and harvesting of crops, hay, vegetables or trees bearing edible fruit; the raising of livestock, poultry, fish, bees or Equines; the harvesting of maple sap and the production of maple syrup; and the management and harvesting off forest lands enrolled in the Use Value Appraisal Program (UVA) also known as Current use.

"Gravel Road" is to be defined as any Town Highway or portion thereof, which Is not paved, and is maintained as a traveled road. **Operation Requirements**

The requirements below must be strictly adhered to when operating an all-terrain vehicle on town highways. Any violations will revoke the permission from the Town of Mount Holly to operate an all-terrain vehicle on the town highways and the applicable State laws will apply.

- 1) All-terrain vehicles must be registered and operated in accordance to the requirements of Vermont Title 23 V.S.A. Chapter 31.
- 2) All-terrain vehicles may only be operated on sections of Town highways that have been designated and approved by the Select Board.
- 3) All traffic control devices apply to the operation of all-terrain vehicles. ATVs shall obey all traffic regulations that apply to other motor vehicles permitted on Town highways.
- 4) All-terrain vehicles on the Town highway will travel to the far right side, single file, not be operated at a speed greater than is reasonable, safe and prudent under the conditions, having regard for the actual and potential hazards there existing. In every event, speed shall be controlled as necessary to avoid collision with any person, vehicle, snowmobile, ATV, or other object on or adjacent to the highway.
- 5) The operator of an ATV shall drive at an appropriate reduced speed when approaching and crossing an intersection or railway grade crossing, when approaching and going around a curve, when approaching a hill crest, when travelling on any narrow portions of the highway and when a special hazard exist with respect to pedestrians or other traffic by reason of weather or road conditions.
- 6) The operator of an all-terrain vehicle being operated on a Town highway will yield right of way to all other vehicle and pedestrian traffic including but not limited to bicyclist and horses.
- 7) ATVs used in active farming must display a slow moving vehicle sign on the rear of the machine.

Highway Approval Process

- 1) All-terrain vehicles will only be allowed to travel on Town highways (or sections of highways) approved by the Select Board.
- 2) The Select Board reserves the right to allow or deny permission to operate an all-terrain vehicle on any Town highway (or section of highway). The Select Board reserves the right to rescind any or all permissions to operate an all-terrain vehicle on Town highways at any time.
- 3) The Select Board reserves the right to add or remove any and all roads from the "Allowed Highways" section of this ordinance at any time.

Allowed Highways

- 1) All Class 4 roads within the Town of Mount Holly.
- 2) All gravel roads within the Town of Mount Holly
- 3) Any road, with the exception of State highways, when the ATV is being used solely for the purpose of active farming.

Enforcement

This is a civil ordinance and shall be enforced by a constable/sheriff/police officer or any person(s) duly appointed by the Select Board as an issuing Municipal Officer through the Judicial Bureau in accordance with the provisions of 24 VSA Chapter 59.

Severability

If any section of this ordinance is held by a court of competent jurisdiction to be invalid, such finding shall not invalidate any other part of this ordinance.

Effective Date

This ordinance shall become effective 60 days after its adoption by the Mount Holly Select Board. If a petition is filed under 24 V.S.A Section 1973, that statute shall govern the taking effect of this ordinance.

SAY 'NO' (AGAIN) TO ATVS ON MOUNT HOLLY ROADS

We don't need an ordinance and additional regulations about ATVs (All Terrain Vehicles) in Mount Holly. Town residents who need to get from Point A to Point B on their ATVs or tractors do so now and rarely does anyone object. We know our neighbors and respect them. They in turn respect us. With the passing of a new ordinance we won't know the many people who will look to Mount Holly as an ATV haven, given that the majority of towns that border us do not want or allow ATVs on their roads. Let's leave well enough alone.

Last year, when the question of whether to allow all ATVS use of Mount Holly roads came up, the Mount Holly Select Board sought the opinions of the town's voters through an advisory vote. After the vote was taken and after the Board held a public hearing on the matter, it was clear that a large majority of Mount Holly residents were opposed to opening up the town's roads to ATVs, and the matter was dropped.

But despite last year's advisory vote the issue has been introduced again by Mount Holly Selectman, Tim Martin, who has proposed a similar ordinance that would basically open up the majority of Mount Holly roads to unlimited ATV use.

According to the proposed ordinance, all class four and gravel roads, would be open to unlimited ATV use, and the ordinance includes language that could allow ATVs even on paved roads. ATV operators would not need to meet an age requirement other than the state minimum of 12 years, nor wear a helmet or carry insurance. Unless posted otherwise on the road, the speed limit would be the state posted limit of 50 mph. Like last year, the new ordinance does not offer any effective means of identifying who is driving ATVs on our roads, so in essence anyone would be able to ride our roads. As mentioned most of the towns bordering Mount Holly, including Shrewsbury, Wallingford, Ludlow, Mt. Tabor and Weston, do not allow ATV's on their roads at all. Mount Holly could well become a magnet for out-of-town ATVers.

Enforcement of any statutes governing ATVs has always been a problem. Last year, when this subject was being debated the first time, a Select Board ATV advisory committee, of which I was a member, was told that ATV complaints and problems would be a very low priority for the Vermont State Police.

The arguments against opening our roads to ATVs are the same now as they were a year and a half ago:

REGULATIONS: Another regulation where the town does not have a current problem or need.

SAFETY: ATVs are not designed for on-road use and the manufacturers themselves clearly state on every ATV, "Never Use on Public Roads"

ENFORCEMENT: there are minimal enforcement provisions, plus the town basically has very limited capacity to enforce;

LIABILITY/TAXES: If ATVs are allowed on Mount Holly roads the town can potentially be held liable for injuries to non-riders. State law does <u>not</u> protect the town from lawsuits by pedestrians or drivers/passengers of cars. This may require higher taxes in order to obtain additional liability insurance or to pay for expensive lawsuits.

ROAD MAINTENANCE: The town road crews would incur additional costs and maintenance due to increased wear and tear to the roads. This would translate to more taxes for all of us.

Last year the town's residents were advised in a Chit Chat ad, to "LEAVE WELL ENOUGH ALONE!" In other words don't introduce ATVs and their inherent problems to Mount Holly roads. That opinion has not changed with this new attempt to introduce an ATV ordinance.




