BRACC UPDATE

Thank you, Mount Holly voters for supporting the Black River Area Community Coalition at the polls. Your financial support, along with that from the Towns of Ludlow and Plymouth allows us to continue providing programs to keep our children safe from the many issues they face in these complex times.

The most recent program for parents and students was March 12 and 13th. John Halligan spoke at the Ludlow Auditorium about bullying, cyber bullying, and teen suicide prevention. He was a dynamic speaker with a powerful message. He reminded the students that each and every one of them is loved more than they know by many people. He told of his personal and his family's heartbreak at losing their son, Ryan, to suicide and urged students who are feeling depressed to talk to an adult. He also told the teens to seek adult help for any friend who tells them they want to kill themselves. About 35 adults attended the evening program. All 7th through 12th graders at Black River Middle and High Schools attended.


Mr. Halligan stressed the powerful impact a student has on a friend when bullying them or being mean to them, especially on the internet. Students asked many questions after both sessions. He told them not to say anything on-line that they would not say to a person's face. It is not anonymous or harmless because you are not face to face with that person, he reminded them. Students seemed to hear his message and the severity of the consequences of Ryan's friends actions.






CLiF Foundation Celebration



assessment. They would review IT projects estimated to cost more than \$2 million, and make recommendations to budget committees for related proposals. An amount up to \$100,000 would enable the oversight committee to retain consultants to provide the needed assistance. The Legislature is looking at all State government IT functions in terms of seeking more accountability.


Our committee is planning to make some updates to our statutes concerning the Office of Notary Public. The statutes are very old, and some issues have been brought to our attention dealing with renewal policies, knowledge of responsibilities, and public protection. Right now renewals are handled by Side Judges and the Judiciary Branch with the fee shared by both. The amount that remains with the Side Judges helps fund a portion of the county budget. Moving their money to the Office of Professional Regulation in the Secretary of State's Office would increase property taxes. OPR has the capability to maintain a database for easier renewals, and also provide training opportunities. Without an improved understanding of a notary's responsibilities, the public could be at risk. We will likely mandate that every notary use an official stamp on documents and keep a log of all actions. The money issue has yet to be decided.

The Appropriations Committee is working overtime to decide where some reductions can be made without jeopardizing programs. It is not an easy task to cut areas that affect so many Vermonters. Some of the things we did not invest enough in such as job training and transitional housing are making it worse. Many moving pieces will not be finalized until we get near our end date in May. The plan is to debate the budget in the House the end of this week.

A bill to create a Joint Legislative Information Technology Oversight Committee has been voted out of our House Government Operations Committee. We want to know if the departments and people responsible for managing our IT services are doing so in an efficient and cost-effective manner. This newly created committee comprising four members of both the House and Senate would provide the Legislature with a project

NITKA'S NOTES FROM THE STATE HOUSE

In the news a few weeks ago was a story about the seizure of approximately one hundred dogs from a home in Eden, Vermont when police executed a search warrant at the residence. The care of the animals was in question and reports stated that persons at the home possibly viewed themselves as running some kind of a rescue operation. It had clearly gotten out of hand. This incident happened one day after the Senate Judiciary Committee took testimony on Senate bill 102. The subject of the bill: "Criminal Procedures; animal cruelty and animal forfeiture" proposes to create a process for asset forfeiture for persons convicted of using animals in animal fights. Animal fighting is not an issue raised in the Eden case. There have been other dog seizure cases in Vermont in which dogs alleged to have been used for fighting were confiscated. Testimony was given by a veterinarian who reported that the nature of the wounds was clearly from fighting and that many of the dogs he saw in one case had to be euthanized due to their injuries. When dogs are picked up by the police in dog fighting cases, they are evaluated to see if they can be rehabilitated to be placed in homes. Some are very appropriate with people and can be placed safely with families while others are too aggressive toward other animals or people and need to be destroyed. The cost of caring for animals that have been seized can run a town into a great deal more debt than they expect. A local police chief testified that a case his town is dealing with has cost his town \$7,000 dollars and expenses are still accruing. Maintence of the animals after seizure as well as medical costs have had to be assumed by the town. Senate bill 102 would allow seizure of real and personal property associated with animal fighting. Persons who engage in animal fighting make money from betting on the fights, breeding fees and selling dogs and puppies. They have training equipment for their dogs to make them more successful fighters and this bill envisions this property being forfeited as well as vehicles and land. The bill included an administrative forfeiture procedure and a judicial process. More testimony will be taken on this bill. The Agency of Commerce and Community Development provided multiple reports this week for the state budget from their various departments. The agency is headed by Pat Moulton-Powden, whom we know in our geographic area from her many years working on economic development projects. Departments under this agency include Tourism and Marketing, Housing and Community Development and Economic Development. Specifically, the Dept. of Economic Development's mission is to improve the economic well being of Vermonters by helping to increase jobs and opportunities, create a robust workforce, improve wages and encourage business start-ups, growth, recruitment and expansion. Eighteen employees handle highly specialized programs for the state such as the VT Employment Growth Incentive, the Windham County Economic Development Program, Tax Income Financing District Program, The Vermont Training Program, Financial Services (Captive Insurance) and International Trade (EB-5 and VT Global Trade Partnership).

VT competes in a global marketplace and ranks as the third largest captive insurance domicile in the world, after Bermuda and the Cayman Islands. Approximately 40 other states have captive insurance legislation and are actively seeking these companies. The captive industry generates approximately 27 million in tax revenue and fees to the state annually. One employee specializes in captives, handles sales and recruitment and the agency hopes to hire an additional person this year who will be paid out of fees. Last year, sixteen new companies came to VT. They employ approximately 1,500 people. The regulation of the industry is through the Department of Financial Regulation (DFR).

Another program regulated by DFR is the EB-5 foreign investment program. As of the end of December, 2014 over \$440,000,000 was invested in VT projects through our regional office. This program involves approvals for citizenship by investors in EB-5 projects. Projects include several Jay Peak developments, Quechee Village, Seldon Technologies, Mount Snow for 34 million, Stowe Aviation for 20 million and Trapp Family Lodge. Recently approved was Timber Creek at Okemo for 34 million. A conservative number of 1800 jobs, direct and indirect are supported by EB-5. The Regional Center will increase its fees this year in order to sufficiently oversee, insure compliance and market projects. There is a lot happening at this agency.

- * The Board received notice that the State, at the direction of the Legislature, has proposed rules to govern the practice of property inspection. A public hearing will be held on March 17, 2015 in Montpelier. Anyone may comment on the proposed rules.
- * The Board reviewed and signed a Liquor License for the Belmont General Store.
- * The Board discussed the letter from the Rutland Town Selectboard which had been tabled last month. Ted Crawford noted that about 20 towns have signed on. During discussion, Peter Berger noted that the issue is to allow towns to be able to participate in the approval process as in Act 250 proceedings, rather than have the solar systems treated as utilities as is currently done. The Rutland Town Board is asking towns to approve a resolution. The process will be researched for next month.

Weston Theater Company Announces Intensive Musical Theatre Program For Teens This August



Water For South Sudan

This fall I read the book 'A Long Walk to Water' by Linda Sue Park, It follows the lives of two children, both in Sudan. Nya is 11 years old and her days were filled with carrying water for her family, leaving no time for education. The other child is Salva, a "lost boy" who spent years walking from South Sudan to refugee camps in Ethiopia and then to Kenya searching for safety and family. In 1996 at the age of 22 he was chosen to come to the United States.

After reading this book I was struck by the need in South Sudan and decided to do something to help. The organization Water for South Sudan based out of Rochester, New York was founded and is led by Salva Dut, the lost boy the book is written about. WFSS has drilled over 200 wells since it was founded in 2003. To drill one well costs \$15,000 - the benefit is huge, sometimes one well can serve several thousand people. The time saved allows women to grow more food and start small businesses, and

gives children time for school. It is estimated that 50-60% of the population do not have access to clean water. South Sudan is the world's newest country, but also one of the poorest. It is estimated that 50-60% of the population do not have access to clean water. As of February 2014 230,000 refugees were displaced in South Sudan, coming from Ethiopia, Democratic Republic of the Congo, and Uganda. And an estimated 740,000 native Sudanese people are also homeless.

My small way of helping is organizing a fundraiser, ordering seeds in bulk from Fedco Seeds and re-packaging for sale. 


words that younger children probably won't understand.

Noah Rourke Identifying Skulls Four Winds - March 2015

Yesterday I learned how you can identify a skull by looking at it's teeth. My group was given a couple of skulls but I worked with what I found out was the white-tailed deer. I figured out that it was a white-tailed by looking at the skulls. I looked mostly at the mouth. The white-tailed had 12 molars, O canines and no incisors on the upper jaw. On the lower jaw he had 8 canines, O canines and 12 molars. The skull was 10 inches long. It also was a grazing herbivore and had no upper front teeth, boney ridge encircles eye sockets, jagged molars and wide sutures where bones meet. Their eyes are to the side. I learned that I can identify a skull by its teeth and by the size of the skull.


