Mt. Holly School Board Meeting

The Mt. Holly school board met on Wednesday, October 5 at the Ludlow Elementary School. The board discussed the revised school calendar due to the delayed school opening. They also discussed the expenditure report and the work that the business office has been doing in preparing data for the state's financial analyst to review in light of the proposed SU change. Mr. Hutt Vater discussed the grant writing and the Four Winds program. The board also discussed the staff courtesy pilot program in great detail. The board discussed open



meeting law and enrollment. Mr. Hutt Vater reported on a proposed pilot program offering Flexible Learning. The PTC has agreed to fund the first session. This program would provide enrichment and acceleration for current students. It could also take in some ADM money for non-students, such as home schooled students or 2^{nd} home owners. This program has been designed to be tax neutral—meaning it shouldn't have an affect on the budget at all, but should still benefit many students. Mr. Hutt Vater discussed NECAP scores and municipal bussing.

The next meeting will be held on November 2, 2011at Mt. Holly Elementary School at 7:00p.m.

Fall Take-Back Day Counters Growing Dangers of Rx Abuse

More Americans are currently abusing prescription drugs than the numbers who use cocaine, hallucinogens, and heroin combined, according to the 2009 National Survey on Drug Use and Health. Studies show that a majority of abused prescription drugs are obtained from family and friends, including from the home medicine cabinet.



You can help reverse this dangerous trend by taking part in the third National Take-Back Day on October 29 from 10 AM to 2 PM. There will be eight collection sites around the state coordinated by the County Sheriff's Departments and staffed by state and local police and members of the region's prevention coalitions. The nationwide event is being organized by the US Drug Enforcement Agency (DEA). Your participation will be anonymous and free. Please bring only pills and capsules; no liquids, inhalers, or injectables




A Message from your Constable

Hunting Season is upon us. Please be aware of the laws regarding the rights of property owners. Be considerate of your neighbors and use caution when handling firearms. Hunter orange is not required by law, but wearing it might save your life.

Posted Property: Whenever possible, the hunter should check with the landowner before going onto his or her land. The right to hunt on privately owned land is not guaranteed by your hunting license. The privilege of using private land for your recreation is extended to you by the generosity of the landowner. It is illegal to damage or remove posters prohibiting hunting, fishing or trapping. In order to hunt, fish or trap on properly posted land, a person must have the written consent of the owner or the person having exclusive right to take fish or wild animals from that land. This also means that a person may not carry or possess a firearm, bow and arrow or trap on land that is properly posted.

<u>Safety Zone</u>: A property owner may establish a 500-foot Safety Zone around an occupied dwelling, residence, barn, stable or other building with signs provided by the Fish & Wildlife Department. These signs shall be placed at each corner of the



landowner.

Posting Signs: Signs prohibiting fishing, hunting or trapping on properly posted land shall be as follows:

• The owner or the person, who has exclusive rights to fish, hunt and trap on the land will post the signs. The owner or person posting the land shall record the posting at the town clerk's office for a fee of \$5.00

- Signs must be not less than 11 inches wide by 8 inches high in size
- Lettering and background on the signs must be of contrasting colors

• The signs must contain the wording that hunting, fishing or trapping or any combination of the three are prohibited or forbidden

• Signs are valid even if additional information is on the sign, as long as a reasonable person would understand that hunting, fishing or trapping are prohibited or forbidden

• Legible signs must be maintained at all times and shall be dated each year Signs must be erected on or near all the boundaries, at each corner and not over 400 feet apart.

Interfering with Hunters, Fishermen and Trappers: It is illegal to intentionally interfere with someone who is lawfully taking fish or wild animals; or to disrupt the taking of any fish or wild animal by harassing or disturbing the fish or animal.



TOWN OF MOUNT HOLLY NEWS

SELECT BOARD - October 11, 2011 - Paul Nevin, Chairman, called the meeting to order at 7:30 pm. Raymond Tarbell and Jim Heald were present.

- 1. The minutes of the regular meeting of September 13 and the special meeting of October 03 were reviewed. There were no corrections or additions. The minutes of both meetings were approved.
- 2. Highways
 - Salt Shed property. Building size was discussed; 60'X120' is anticipated.

• Station Road High Bridge. The Town could decide to discontinue this bridge. FEMA rules allow for funding to be used for an 'alternate project' in a case like this, but an official stand must be made. The bridge would still need to be made safe for pedestrians and snowmobiles. The Vermont League of Cities and Towns (VLCT) will be contacted for help with the official procedure for closing a bridge. The bridge currently has some blockage in front now; the Sno*Drifters (C. Marechaux) would like to see Jersey barriers with access allowing snowmobiles but not the groomer.

- Belmont Road bridge at Mount Holly store. As the water has receded, this bridge is in bad shape and may need replacement. Tom Roberts (VAOT) looked at it. The Town may be able to get 100% funding for it from the State. The bridge was shored up today, but likely will need replacing within a year. Further action will wait on the State report.
- Branch Brook Road: D. Dieters noted that a pond on this road was breached, taking out several driveways and other property damage. A State dam safety inspector (Steve Bushman) looked at it today and feels it is compromised. The Emergency Watershed Protection Program may provide grants for this type of work. The highway crew will look at it and see if the Town can provide ditching and culvert replacement.
- 3. Report of Treasurer.
 - David Johnson presented an income and expense statement dated September 30, 2011 showing cash balances of \$2,808,037. Property taxes totaling \$847,393 remain to be collected. None are delinquent.
 - David also reported he has reviewed a number of miss-postings in the trial balance, which he will need to review with the Auditor, such as a payable for VT unemployment taxes. The Town pays this through the VLCT insurance, not to the State program.
 - Road repairs post-Irene have totaled about \$160,000 to date, most of it for the trucking of materials by other than town trucks and the fill material itself. Where will that money come from? From the General Fund, with anticipation of FEMA and State funding, which should provide 90% reimbursement. The road crew was again commended for their work.
 - FY2011 Audit (Financial Statements): This is still in draft form. David asked for the Board's preference on how to show the Highway grant revenue and expenses. Some felt that when the Audit was available, it should be put on the town website. The Board noted that copies will be available at the town office. The auditor's list of recommended procedures has not been received yet.
 - A. Lynch requested a report of budget vs. expenses for the Listers and the Planning Commission.
- 4. Solid Waste:
 - The last Wednesday for the Transfer Station is tomorrow, October 12. There has been feedback from residents (thru the station personnel) to keep it open a second day thru the winter, Sunday 9am – noon. Upon motion made and seconded, it was

VOTED: To open the Transfer Station on Sundays for 3 hours thru the winter.

- The Board will monitor the extra cost for Transfer Station personnel as well as extra road crew costs versus the usage.
- Single Stream Recycling. Paul Nevin presented

information from the RCSWD about this. Casella Waste Management is scheduled to start using their new machine in November. This would allow all recyclables in one container, rather than the current system which requires separating each type. There could be some initially higher costs (the town would ideally need a second compactor) but overall should save money thru less garbage tonnage. Single stream has shown 30-40% lower costs in areas that have switched to this. During discussion, it was noted that the rumor this is shipped to China to be sorted is false: it is done in Rutland at Casella's facility. The recyclables can be compacted or loose, but if loose would require more frequent pickups and thus more cost. The Town can decide to keep some things as they are, such as the newspapers going to the farm and keeping metals here, which currently provide some revenue to the town. The Board decided to table any decisions

- A resident of Old Turnpike Road presented documentation of property damage by a neighbor's domestic animals. The animals frequently escape the enclosure and are out in the roadway as well as chasing the neighbors. The Sheriff's department doesn't handle domestic animals. The Board will contact VLCT regarding how to proceed and also the Sheriff's office regarding other town's experience with such problems.
- The Town recently received reports from the Sheriff's Office regarding several complaints about a dog on Maple Hill Road, which occurred over several months. The owner of the dog was present. The owner stated she only received a copy of the reports today from the Town Clerk. She feels there are inaccuracies in the reports and wanted to understand the process. The Board reviewed the Town's Dog Ordinance, which states that a dog must be under an owner's control at all times. The owner stated no one has spoken with her and she was unaware that her dog was a problem. The Sheriff's reports state they have made several attempts but have been unable to reach the owner. The Board reiterated that the dog must be under control at all times, and with a number of incidents, the owner has some liability issues.

6. Insurance.

• The PACIF (property and casualty) insurance renewal application was presented for signature. The application reflects the new (higher) property valuations for Town-owned buildings which were done last spring. The anticipated increase in

the premium for the properties is about \$3000. This will affect the MHCA, which shares the cost of the insurance on the Library building.

- Health Insurance: The VLCT health insurance offerings have been expanded to provide more options to member municipalities. The Town will be required to select a new plan, as the current one will no longer be offered. Some information was received yesterday, but the file appears incomplete. VLCT will be contacted for an updated file and information will be given to the employees for their review. A decision must be made by November 15 to enable timely enrollments in a new plan.
- 7. Planning Commission:
 - Subdivision Regulations. The Board requested a comparison sheet showing the old and new regulations side by side. The Board also requested the specific areas in the Town Plan which would need to be changed based

on the proposed regulations. Ray Tarbell noted he was against requiring all utility services to be underground. Underground utilities require extra work and hand-digging by the town crew when doing road and culvert work. Any damage results in fines, and large ones (\$5000) in the case of fiber optic cable.

- Rutland Regional PC. Hazard Mitigation Plan: This is now up in the air, as FEMA and the State have decided that a new plan is likely needed, as a result of Irene.
- Administrative Officer: Both interested individuals have withdrawn. The position will be re-advertised.
- There has been no expression of interest in the two terms ending in November. The vacancies will be posted and advertised again.
- Complete Streets Law. This law took effect July 01, 2011. It is intended to encourage multi-modal transportation throughout the state, but there are many exceptions and probably does not affect Mount Holly.
- 8. Other Business
 - Catamount Trail Association No further word on this.

WORKING GROUP meets the second Monday of the month, at 7 p.m. in the Town Office. The Working Group is not only open to all; it consists of everyone who attends a meeting. The Working Group assists the Planning Commission with strategic planning because the regular Planning Commission meetings are often devoted to administrative activities such as subdivision applications. The Working Group met on Monday October 10. 2011. S. Howard, P. Smith, T. Martin, A. Lynch were present. There was a spirited discussion of economic development in Mount Holly – the needs of large and small entrepreneurs, the growing intensive agricultural enterprises, the relationship between housing and jobs, and the role of shared clerical and technology support centers - which ended with agreement that the Commission's Economic Development Committee should be revitalized. The names of persons who might be able to devote some time and energy to the Committee were noted and it was agreed that Hal Kirshner (who chaired the Economic Development Sub-committee in the 2003-06 community planning efforts) should be asked to take up his leadership role again. Housing Task Force ~ In August 2010, the Housing Task Force (HTF) was beneficiary of a \$4,283 State Municipal Planning Grant. The task force was able to use this funding to organize a formal effort to review and develop housing opportunities within Mount Holly. It also enabled us to hire the Vermont Design Institute (VDI) to facilitate community problem solving as it relates to housing needs. Over the last year the group engaged in planning, a town wide housing needs surveys and it culminated in a full day design workshop. The workshop brought together a volunteer group of architects, community designers and engineers who worked with residents of Mount Holly to review three housing opportunities. This work has been developed into a final report and was presented on Sept. 22 to a combined meeting of the select board, school board, planning commission, housing task force and interested citizens. The discussion covered why affordable housing was needed in Mt. Holly, the optimal site for locating the housing, issues of concern and what next steps were needed to continue moving this effort forward in compliance with the town plan. The outcome was the decision to apply for an additional planning grant and to review the optimal use of the area surrounding the town municipal center. This effort would include reviewing the areas septic and water potential, commercial development opportunities, the placement of town buildings and housing for school families and seniors. Dear Editor,

There is confusion over how much the recent catch up audits have cost Mount Holly and its taxpayers.

On October 3, the almost completed audit for 2009 - 2011 was presented at a special meeting called for by the Select Board. The auditor, chosen by the Select Board, informed the selectmen and residents that the current bill was \$90,851 and that her work was not finished.

The question is, are we worse off because the audits were not completed in a timely and appropriate manner? The answer is yes. Audits are required every three years under state law and called for annually as voted by the Select Board. Because an audit was not done each year, the recent catch-up audit required an extraordinary rebuilding of the town's books in order to ascertain their accuracy, resulting in this huge cost.

At the next Select Board meeting, the town treasurer indicated that the cost of the catch-up audit was covered by unused amounts budgeted for audits in earlier years. However, the numbers do not bear this out. The following figures identify the costs Mt. Holly faces:

Amount budgeted 2009/2010	\$16,000
Amount spent on incomplete 2009/2010 audits	<u>5,900</u>
Amount moved to the General Fund	\$10,100
Cost to date of current audit	\$90,851
Budget for 2011 audit	8,000
Cost over budget	\$82,851

Except for the amount of \$8,000 included in this year's budget, the remaining cost will come out of the general fund or through increased real estate taxes. The general fund could also be called our rainy day fund, used to cover real unplanned emergencies, such as Hurricane Irene type storm damage, excess snow removal, or other unplanned for needs. On June 30, 2010, the general fund had \$70,513 available in its unreserved fund category.

As mentioned earlier, the town budgets \$8,000 annually for an audit. This would be a reasonable amount given well organized financial records. Francis DeVine

Frequently Asked Questions and Clarifying the Myths about SBA Assistance

The SBA can assist homeowners? Isn't this the Small <u>Business</u> Administration??

It is. But, for **homeowners and renters** in counties that are in federally declared disaster areas, SBA may be a good resource to pursue. The SBA can provide low-interest loans to eligible borrowers with very favorable terms. They can't provide you with a loan to build that in-ground pool and steam room that you have been dreaming of, but they can help with damages to your home caused by Tropical Storm Irene.

Don't let the word "business" mislead you. Over 70% of the assistance SBA is providing for Irene recovery in Vermont is going to renters and homeowners.

I am a small business owner that has already borrowed from VEDA. Can I still access SBA funding?

Sure. If the VEDA loan (and any insurance settlement) isn't going to cover your needs, you should absolutely talk to SBA. Their borrowing limit is \$2million.

The average SBA business loan for Irene recovery in Vermont is close to \$115,000; a monthly payment on that amount could be \$550. SBA will consider rolling anything you have already spent on recovery into that loan. And just like home loans, SBA can consider refinancing existing obligations to make repayment affordable. SBA will give you time to get back to normal; payments don't begin until five months after the loan is made.

I've heard that the application process for an SBA loan is very time consuming and the approval process takes way too long.

It's a loan application, so there are details to be addressed, but it isn't difficult. The best way to approach an SBA loan is to tackle it with an SBA **Representative** at a disaster recovery center or a **Vermont Small Business Development (SBDC) Counselor** or call **the SBA Help Line at 1-800-659-2955**. That way, you will ensure that all of the information is complete.

I received this from Gus Muguira from California in December 2007 and have kept it just for theNovember publication of the Chit Chat.

The application for businesses is only two pages long and you probably have most of the information handy anyway. I am pretty sure that I won't qualify for an SBA loan. Why should I even bother to try?

What makes you so sure? You won't know until you talk to an SBA Representative. If you are a business owner, homeowner, or renter in an eligible county and are seeking assistance to rebuild your business or home, it is worth taking a few minutes to chat with the SBA folks or a Vermont SBDC Counselor. Or, you can call the SBA Help Line at **1-800-659-2955 I have received a grant from FEMA, but I still need to make more repairs to my home. Can I still pursue SBA funding?**

Yes. FEMA assistance normally doesn't cover everything that homeowners need to fully repair their homes.

If SBA does offer you a loan they will do everything they can to make it affordable. The average home loan for Irene recovery in Vermont is \$47,000; monthly payment could be \$187/month with SBA's 2.5% rate and 30-year term.

I have been told I have too many assets to qualify for SBA assistance

SBA loans are based on the damages caused by Tropical Storm Irene and your ability to repay. It is not based on how many assets you have or don't have.

How long will the test last?

We anticipate that the test will last approximately3 minutes. While state and local EAS messages are limited to 2 minutes, there is no time limit for national EAS alerts. To evaluate whether the system properly interprets the national message code in the national EAS test, the message duration must be longer than two minutes.

Why is the national test being conducted at this particular date and time?

While EAS tests may be disruptive, they are important to ensure that the EAS is functional and that EAS Participants are prepared to issue alerts, and it is our intent to minimize disruption and confusion to the extent possible. The November 9 date is near the end of hurricane season and before the severe winter weather season begins in earnest. The 2 PM EST broadcast time will minimize disruption during rush hours, while ensuring that the test occurs during working hours across the United States.

What is the source of FEMA's and the FCC's authority for conducting the national EAS test?

Pursuant to the FCC's rules, EAS Participants must take part in nationwide tests of the EAS. The Department of Homeland Security (DHS), which administers the EAS, has the

National Academies: Ethanol Worsens Greenhouse Gases From: Joseph McDonald

The report, requested by Congress, concludes that ethanol increases greenhouse gas emissions, pollutes water and uses more water in its production than gasoline. It says that cellulosic ethanol is very unlikely to meet its Renewable Fuel Standard mandates by 2022. Indirect land use changes due to biofuels production will zero out any potential benefits of lower greenhouse gas emissions from biofuels and may actually increase them in both the short- and long-term.

To date taxpayers have spent \$23 billion between 2005 and 2010, or \$6 billion a year, subsidizing corn-based ethanol without significantly reducing reduction in America's use of fossil fuels. The report is yet another reminder that significant reforms to the renewable fuel standard are critical, including the addition of strict and enforceable environmental safeguards.

"The Renewable Fuel Standard has always been about corn, corn and more corn," Karpf said. "The fact is, it won't bring energy independence, protect our air or combat global warming. As our country faces record national debt, it is time to put American taxpayers and our soil and water ahead of entrenched special interests."

American farmers have diverted 40 percent of corn production from food and feed to fuel. Land once used for soybean production has been converted to corn to meet the demand for biofuels set out in the RFS. The new report provides more evidence that corn ethanol production continues to raise food prices around the world and harms the planet by releasing more greenhouse gases than regular gasoline.
