



He was a 1942 graduate of Towle High School in Newport, NH and a 1947 graduate of Providence Bible Institute in Providence, RI. He received his BA in Psychology at Upsala College in East Orange, NJ.

He was the former Pastor of the Calvary Baptist Church in Warwick, NY, the First Baptist Church in Georgetown, NY, and for 31 years at First Baptist Church in Newton, NJ.

He married Eleanor May Grover on June 17, 1950 in Holbrook, MA.

Allan enjoyed fishing, woodworking, and spending time with his family. In his youth he played the violin with his sisters in a musical ensemble and performed for various clubs and occasions. He enjoyed playing his trumpet in his High School band and in a gospel group in his college years.

He had the gift of encouragement, and spent many hours counseling hurting hearts. He had a wonderful sense of humor and was always ready with a joke or pun. His life goal was to share the message of the gospel with all who had ears to hear.

In his retirement years he faithfully attended the Village Baptist Church in Belmont, VT and served as a deacon and taught a Bible study class for many years. With a servant attitude, he was known to use a hammer, vacuum or chainsaw wherever they were needed. He went on several mission trips overseas, digging ditches, using carpentry skills on missionary homes, and preaching in evangelistic crusades.

He was predeceased by his wife, Eleanor M. (Grover) Davis who died on January 12, 2007, and by his sister, Dorothy Johnson. Survivors include two daughters, Kathleen Johnson of Newark, DE, and Martha Dunn of Pineville, NC; two sons, the Rev. Glenn Davis of Mt. Holly, VT and Scott Davis of Chester Heights, PA; a sister, Carolyn Guevin of Wilbraham, MA; 12 grandchildren; 8 great-grandchildren; nieces and nephews.

The funeral service was held at 11:00 am at The Village Baptist Church in Belmont, VT on Saturday, January 22nd. Visitation



was held immediately after the service downstairs in the church Fellowship Hall. Interment will take place at a later date for family in the Woodlawn Cemetery in Rochester, VT.

Scheduled Rabies Vaccination Clinic

The Mount Holly Town Office along with the town's ACO will host a rabies vaccination clinic on Saturday March 26th from 10am till 12 noon. At this same time the town office will be open to make it convenient to register your dog. A Rabies shot and certificate is required to get your dog licensed. This clinic is also open to cats.

The cost of the rabies shot is 20.00 Dollars in addition to the cost of the license. The cost of the license is 11.00 for a spayed / neutered pet and 15.00 dollars for unneutered prior to April 1st, the due date for licensing. After April 1st a late fee will be applied.

All dogs must be on a leash and please have cats in a carrier. The attending Veterinarian will be Dr. Carol Gifford of Riverside Veterinarian Care. Masks will be required to enter the town office. If you have any question you can reach out to

The coming summer will be a wonderful chance for Vermont kids to spend a week in the great outdoors. It's a week packed with educational and fun experiences. It is because of your generosity that about 400 kids each summer, spanning at least two generations, have been given

the opportunity to enjoy this wonderful outdoor learning experience. We appreciate all you have done, and we hope you will continue your support during the summer of 2021.

This year, as we did last year, we having parents entering their child's application via ANR Online at: httos://anronline.vermont.gov/?formtag=GMCC We ask that you encourage everyone to apply using ANR Online. The fee for the summer of 2022 will remain at \$250.00 per session and you will be billed at the end of the summer. We will be opening registrations for 2022 on January 3rd, 2022.

As in past years, parents must contact you first and have you fill out and sign a copy of the attached "2022 Sponsorship Agreement" form before going online to register their child. it is the parent(s) responsibility to send the sponsorship agreement form in with their child's application. I have attached a copy of the 2022 form for your convenience, so please feel free to make whatever copies you may need. You must use the current 2022 version of the form. Whited out, crossed out, or re-written copies of the sponsorship agreement from will not be accepted. This is 2022 version of the only form that will be accepted as **proof of sponsorship.** Continued use of the sponsorship agreement form will help ensure you are billed only for campers who have been approved before the season.

(Please make note of the new phone number for GMCC) Parents and guardians should be reminded to keep a copy of Sponsorship Agreement for their records until at least November.







each year has felt unique in its own way.

This year the uniqueness comes from redistricting, with the state receiving the data from the decennial US census. Based on that data, we know that the ideal population for a single-member house district is now 4,287 (based on the state population 643,077 divided by 150 representatives). For reference, based on the new census data our district now has 4,653 residents, which is 8.5% more than the ideal size. So our district may look a little different in the next election. Although I will caution it is still VERY early in the process, so a lot of things WILL still change. But there are a couple different district map proposals out there, with one carving out a section of Gates Road in Mount Holly from the rest of our existing district, and those residents would then

with vote Wallingford,

Clarendon and West Rutland for two House seats, while another proposal would put Mount Holly and Shrewsbury with Wallingford and put Ludlow with Plymouth, Andover and Weston.

All of these proposals are now in front of the House Government Operations Committee for consideration and they will be the ones to create the final map, and they will be holding public hearings for input as part of the process. While they may start with one of these maps as a base to begin their conversations, we may still end up with a completely different district than what has been proposed thus far, hopefully similar to what our district looks like now.

All of this work is going on in House Gov Ops in addition to major progress with the state employees' pension negotiations, which I plan to elaborate on more next month as that plan moves through the House.





Senator Alison Clarkson's Legislative Update 9 January 2022

The 2022 Vermont Legislative Session is off and running. As this is the second year of our Biennium, we dove right in on Tuesday January 4th. Sadly, this is also the second year in which the COVID-19 pandemic is impacting our ability conduct our business in person at the Vermont Statehouse. Given the anticipated post-holiday surge of COVID cases coupled with the tidal wave of the Omicron variant just hitting Vermont – it seemed the prudent move to begin our 2022 Session remotely to protect the health and safety of the public, our members and staff. While we are disappointed to have to delay in person work – it is wonderful that we have an effective electronic alternative – and can meet via Zoom.

As a result of the Legislature's pivot to on-line meetings the public now has the greatest increase in access to our work in our history. Every Committee meeting is available to watch in real time on YouTube. Those links can be found on our Legislative webpage: legislature.vermont.gov .If you are interested in following an issue - I encourage you explore this website. Each

Committee webpage has the Agenda for the week, the YouTube links, the bills in that Committee and all the Reports and Documents supporting the Committees work. Never has Vermont's legislative work been so transparent and accessible.

Our Legislative priorities revolve around 4 key areas: Workforce, Housing, Climate Change and the continued work of responding to COVID-19's persistent challenges and the needs of Vermonters. Plus, it is a year with a number of things we must do: Re-Apportionment (precipitated by the Census), vote the two Constitutional amendments out of the Legislature and to the public for November's election, act on the Climate Council's recommendations, and respond recommendations made by some key off-Session Task Forces which addressed: Pensions, Education Finance and the Weighting Formula, and Health Care Affordability. addition, addressing Social Equity issues is a priority. course there are the perennial requirements for a Legislative Session like the Budget and Judicial Retention. And, we only have five months to do this work, as we usually adjourn in mid-May.

This Session I continue to serve you in the Senate as vice-chair of Senate Economic Development, Housing and General Affairs and on Senate Government Operations. In addition, I am the Majority Leader in the Senate. I have been appointed to work on the Senate Re-Apportionment Committee and State Workforce Development Board. I am also a member of the Climate Solutions Caucus, the Women's Caucus and the Social Equity Caucus.

We have a lot to do in short order. In response to COVID-19's continuing impact on our ability to gather safely in person, Senate Government Operations moved swiftly to enable the safe functioning of democracy. We set a new record – passing out 3 bills in the first 4 days of Session, 2 of which have passed the Senate Floor already, and one of which has made it to the Governor's desk to be signed. For a second year we needed to make it possible in 2022 for Towns - to move Town Meeting, to vote by Australian Ballot, to hold Informational Meetings and public meetings remotely, and for local candidates to not have to collect signatures.

- 3. Changes and/or additions to the Agenda None were necessary.
- 4. **Town Meeting Articles -** Jennifer Matthews referenced the VT League of Cities & Towns Model Town Meeting Articles. She noted that we Select Board

members had already decided to put an article on the Annual Town Meeting Warning regarding retail cannabis so voters could decide the issue. Ms. Matthews read the wording for the article per VLCT: "Shall the town authorize cannabis retailers in town pursuant to 7 V.S.A. § 863?" Discussion ensued. Mr. Turco made a motion to add the article to the Warning, seconded by Ms. Matthews, unanimously approved. Ms. Matthews also noted an article to eliminate the elected Auditor. She explained that the Town is not in compliance with State Statutes as the Town Auditors are not fulfilling the functions set out by Statute. Our Town Auditors are more of a town report committee; we hire a professional auditing firm to review our financial records. She stated the need to address this in order to bring the Town into compliance with Statute. Ms. Matthews also noted the article to eliminate the elected Lister. Once the new State regulations come into being, we might want to consider the option of subcontracting the Grand

List work. Ms. Matthews also noted an article allowing the Select Board to appoint the constable. She spoke of all the work done by the Select Board to enforce the Junk Ordinance, only to hit a stumbling block when it came to issuing the necessary tickets. She explained the article, if passed, would allow the Select Board to appoint a constable, even sharing a constable with a neighboring town. After mentioning several other articles already included on the Warning, Ms. Matthews noted the article to pay the town clerk a salary only. She explained that at present the town clerk is paid \$38,740 a year for a part-time job plus almost \$30,000 in fees. She stated she did not think a pay rate of over \$44 an hour was being fiscally responsible as far as the taxpayers in Mount Holly are concerned. Ms. Matthews further explained that the majority of towns in Vermont now pay their town clerk a salary only; the fees go into the General Fund to offset expenses. When a town clerk does receive the fees, the salary is usually \$13-14,000 a year. Discussion ensued about other towns' pay rate (average of \$25 per hour); hire

dates of other town clerks. Ms. Matthews stated she thought the voters of Mount Holly should have the right to determine if they want to pay a part-time town clerk close to \$70,000 a year plus full benefits. She noted we are asking voters to determine whether or not to allow retail cannabis in town; why shouldn't voters decide whether or not to pay a well-compensated town clerk an additional \$30,000, money which could instead go to offset expenses, thereby keeping taxes lower? Mr. Turco asked for a motion. Ms. Matthews made a motion to ask voters to decide to compensate the town clerk with a salary only, no fees. Discussion ensued about appointed vs. elected town clerks; fluctuating fee amounts from year to year; other towns' pay rates; changeover date (1980s-90s) to salary only by other towns; full benefits (health, dental, retirement); the wording of the article. Ms. Matthews pointed out this was just a decision to put an article on the Warning to let voters decide whether this compensation package is okay with them, and the decision rightfully belongs with the taxpayers. Neither Jeff Chase nor Mr. Turco would second the motion. Ms. Matthews stated she interpreted that to mean they thought it okay to pay a 30-hour-a-week town clerk close to \$70,000 a year plus full benefits. She stated she greatly disagreed with that.

- e. **Mask Recommendation Municipal Properties** Given the huge spike in COVID numbers in town, Mr. Chase made a motion to implement a mask mandate for all municipal properties through March 31, 2022, seconded by Mr. Turco, unanimously approved.
- f. **Board of Adjustment** tabled until the February meeting.
- g. Planning Commission Appointment One Term to November 2024 Three letters of interest received by the Monday, January 10th @ Noon deadline: one from David Martin, one from Anna McGee Hanson, and one from Andrew Seward. Based on the right demographic, Mr. Chase made a motion to appoint Andrew Seward to the Planning Commission for a term running to November 2024, seconded by Mr. Turco. Mr. Chase and Mr. Turco voted yes in support of the motion; Ms. Matthews voted no.
- h. Other There was no other Ongoing & Old Business this evening.
- 7. New Business
- a. **Application Fee Schedule Refunds –** Mr. McCann reported the Planning Commission resolved to ask the Select Board to make a change to the Fee Schedule in order to put applicants on notice and to give the Planning Commission clear guidance on whether or not a subdivision fee can be refunded. Discussion ensued. Mr. Chase made a motion to add this information to the Application Fee Schedule: "Application fees are non-refundable unless the application is withdrawn before the Planning Commission begins consideration of the application," seconded by Ms. Matthews, unanimously approved.
- b. **Set Date & Time to Sign Annual Town Meeting Warning** Meeting is set for Thursday, January 20th at 4:00 pm at the town office. Information and costs to program the ballot machine will also be on the agenda.
- c. **Annual Town Meeting Attendance Guidelines -** Meeting in the Mount Holly School gym will be a hybrid meeting with both in-person and Zoom attendees. For in-person attendees, masks will be required, and seating will be at six-foot intervals except for couples or members of the same household. Moderator Andy Tanger will put together Zoom guidelines for the meeting.
- d. **Act 60 Changes** Ms. Matthews reviewed a few of the pertinent changes to the Act 60 election law, made by the Vermont Legislature last year in response to the pandemic: the Board of Civil Authority (BCA) can vote to authorize an outdoor and drive-up
- polling place; the Select Board can vote to mail a ballot to all registered voters for municipal elections, with cost covered by the town (VT Secretary of State mails ballots to all registered voters for the November election); the BCA can vote to process ballots during the 30 days preceding an election with processing into tabulator done by the town clerk and two BCA members, one from two different parties, during normal business hours.
- e. Other FY'22/23 Budget Approval Mr. Turco stated Select Board members went through the budget line-by-line, decreasing some figures where possible, thereby keeping the municipal budget to a 1.4% increase. Discussion ensued about including the cost for law enforcement of the new speed limits once an ordinance is passed. Ludlow Rotary Hears about Divided Sky Foundation's Plans

The Jan. 4 luncheon meeting of the Ludlow Rotary Club (LRC) featured the Program Director for Divided Sky Foundation, Melanie Gulde, speaking to Rotarians and guests about plans for the future drug and alcohol recovery program on Fox Lane.

The Divided Sky Foundation, founded by Trey Anastasio, purchased the facility in Ludlow. Anastasio of the band Phish, himself 15 years sober, launched the Divided Sky Foundation to deliver help to those affected by substance use. Vermont, his adopted home state, is a natural place to begin this chapter of his own giving back. Divided Sky is dedicated to delivering quality care and compassionate programming to those affected by alcoholism and addiction.

Acquiring the facility site was the first step in a plan that includes building renovations and program development. The **program** is tentatively slated to open by the end of 2022. Objections from neighbors have delayed the opening as planned.

The purchase was made possible in part by funds raised in 2020 during Anastasio's The Beacon Jams, an eight-week virtual residency presented live from New York City's historic Beacon Theatre. Donations were encouraged

throughout the run, with fans ultimately contributing more than \$1.2 million.

"Alcohol is an addiction that seems to be overlooked at times. 95,000 people die annually from alcohol-related causes according to the National Institute on Alcohol Abuse and Alcoholism." said Gulde. She emphasized that addiction to alcohol is the most prevalent addiction facing our society.

The program's goal: to be a local asset for giving back to the community. The non-profit program plans to serve people from all income levels. Care services being planned include maintaining recovery, with plans and programs tailored to individual guests' needs. In addition, the program plans to offer job training and workforce reintegration. Education opportunities are planned to prepare guests who need them with certification in skills and trades.

Gulde provided a tour of the facility after the formal meeting.

Lake Ninevah's 2021 Aquatic Invasive Species Prevention Program

As the ice and snow begin to cover Vermont and we wrap up 2021, Ninevah Foundation would like to thank everyone, near and far, who loves and enjoys Lake Ninevah for yet another successful year of the Lake Ninevah Aquatic Invasive Species Prevention Program! This was the 20th year this program has been supported by the Vermont Department of Environmental Conservation (DEC) Aquatic Nuisance Control (ANC) Grant-in-Aid funds. Along with this grant funding, Ninevah Foundation provides matching funding through donor support, program coordination, and staffing. Two decades of invasive species prevention at Lake Ninevah would not be possible without the initial and continued support for the lake community who began the annual work to raise funds, apply for VT DEC grants, coordinate greeters at the public access, and ensure the lake is surveyed every year since 2001.



This summer, our Lake Ninevah greeters were able to complete over 1,000 hours checking over 1,200 boats entering and leaving the water from public access. Boat checks are part of the "Clean, Drain, Dry" initiative in preventing hitchhiking plants. Big thank you to our Lake Ninevah greeters Ron, Mike, Aryk, and Judson for their work this summer!

Additionally, we completed 20 hours surface and scuba surveys of Lake Ninevah this September with the combined efforts of botanist and ecologist Michael Lew-Smith from <u>Arrowwood Environmental</u> and Kelly Beerman, Conservation Director for Ninevah Foundation. Luckily, we did not find any invasive plants on the <u>Vermont watchlist</u>. Thanks to the team at Arrowwood for the intensive surveys and VT DEC for the ongoing <u>Vermont Invasive Patroller (VIP)</u> training and resources helpful for completing surveys.

Did you know you could get training to be a VIP, too? If you are a regular visitor of Lake Ninevah and would like to learn more about aquatic plants and survey methods, please reach out to Kelly Beerman at kelly@farmandwilderness.org for more information of how to become trained and jump on the schedule to survey Lake Ninevah in 2022!

Prevention measures such as greeter programs and surveys help waterbodies keep invasive species like water chestnut, Eurasian watermilfoil, zebra mussels, and more from spreading. Over 125 Vermont lakes, ponds, rivers, and reservoirs have known invasive species infestations. Luckily, Lake Ninevah is not on that list which is why it's important that these prevention programs continue in the future.
