#### John A. Puro

John Anderson Puro passed away on Jan. 22, 2022, at the age of 82, from complications of COVID-19. Big John was born in Jersey City, New Jersey, into a proud Finnish family on April 26, 1939.

His formative years were spent in Fitchburg, Massachusetts. He spent summers at his grandparent's farm in what he called "God's Country" (Mount Holly, Vermont).

John was an excellent provider for his beautiful wife and five kids. He retired from the phone company in the mid-'80s, he went on to start one of the biggest scrap metal recyclers in Vermont called Vermont Metal Exchange (VMX).

From 1978 to 1983, the Puro family owned a corner store in Georgia, Vermont. Johnny was an entrepreneur and loved to save a buck. If he saw an opportunity to make money, he took it. He once bought hundreds of cans of succotash that were on close-out that his poor family had to eat with every dinner for what seemed like years. In 1980, a customer at their store used his meat scale to weigh some silver. As he walked out the door, he handed Johnny \$50. This was a "light bulb" moment for John. For the next 40 years, John's side hustle was dealing in rare coins, jewelry, bullion, gold and silver.

John joined the United States Air Force in 1957. He switched to the Army National Guard in 1963. An accomplished soldier, John graduated last in his Officer Candidate School class, but was first of the group to become an officer. A veteran of the Vietnam War, John spent most of his time stateside as the Vermont National Guard Armory Commander in Ludlow. He also assisted in training the 10th Special Forces Group (Airborne)/1st Special Forces. He earned a marksman badge with his pistol and sharpshooter designation as a tank commander. He competed in numerous shooting competitions representing the Vermont National Guard. He received many medals during his tenure in the service, but his proudest accomplishment was his Vermont Governor's Commendation for his heroic efforts during the Vermont floods of 1973.

John always provided a comfy home for his family. Everyone was welcome. But if you swam in his pool ... you had to help stack wood. The Puro family spent many summers on Burr Pond in Sudbury at their camp. He built a basketball court (which he blew up ... long story) that was flooded in the winter for skating. Johnny was never shy of having a good time. He loved to shoot pool, play cards and was an excellent golfer. John discovered "Saaaaaalsa." He invented the words "beeflelorken," "weefle," "hungala" and "nurgle." He loved music, and partied with Tony Joe White and Bo Diddley. In the late-1970s, he talked his way into a press pass and spent two spring training seasons with the Boston Red Sox in Winter Haven, Florida.

John was fiercely protective of his family and possessions. In 1982, culprits tried to run over John with their car after burglarizing his corner store in Georgia, Vermont. John emptied his trusty Llama 1911 .45 caliber into the car as it sped away. While the bad guys escaped, blood and glass were found on the road. When asked by the State Police why he took the final shot when he was not in danger, he replied that he was trying to "kill the \$%^\*\*^!" That was not the answer the police were looking for



and he was arrested. He was given a one-day suspended sentence for discharging his weapon.

John was predeceased by his loving wife of 61 years, Marcia; daughter, Susan; sister, Elsie; and grandson, Stephen. He is survived by four of his children, Liisa and her husband, Brian,







#### Senator Alison Clarkson's Legislative Update

Town Meeting 2022 reminded me how resourceful and nimble Vermonters are. This was our second Town Meeting season conducted during the COVID pandemic. Most of us are now comfortable operating in the virtual universe and have grown quite adept at managing meetings on Zoom or Teams. So, this year, there were options.

Of the ten Windsor District Town Meetings or Informational Meetings I was able to attend, most were hybrid with people attending in person and virtually. Several were entirely virtual and only one was conducted fully in-person. A number of Informational meetings were held well in advance of the Australian Ballot voting, which was held on Town Meeting Day, Tuesday March 1<sup>st</sup>. And, at least seven towns, Cavendish, Ludlow, Rochester, Baltimore, Londonderry,

Stockbridge and Weston, have rescheduled their Town Meetings to later in March, April or June. While I was honoured to be asked to speak at all ten meetings I was able to attend, it was a real treat to once again be able to meet in person at some of the hybrid meetings and to catch-up with so many. And for those virtual meetings, I was afforded the rare opportunity to sample more of our Windsor District municipal life without having to drive an hour or 45 minutes between meetings. I really appreciated getting a flavor of the issues our towns are addressing and seeing municipal government successfully adapting to new forms of civic engagement.

Only 40 towns in Vermont had a fully 'in-person' town meeting. And, in Windsor County, Barnard held that distinction. I was glad to be able to join Barnard's meeting. It was great to visit with so many, despite the fact that no delicious lunch was served. And, it began with an in-person vote for the Selectboard.

As a state senator, I represent about 55,000 people in 26 towns. With 977 square miles, Windsor County is physically the largest county in Vermont. The District also includes Mt Holly (Rutland Co.) and Londonderry (Windham Co.). It is often hard to get to know people and towns you don't live in and that are so far apart. So, a silver lining to this brutal COVID pandemic has been the ability to attend meetings I couldn't have otherwise, simply because of the constraints of schedules and travel time. Meetings on virtual platforms have meant that, in addition to town information sessions, legislators have been able to attend more chamber, supervisory unions, regional development, regional planning, selectboard, human service meetings and special forums than ever before.

Our virtual world has also enabled more civic engagement at the state level as well. All of our Legislative Committee meetings are accessible on YouTube via a link on each Committee's webpage on our legislative website listed below. If you are interested in following a bill or an issue, explore which committee it is been assigned to and find out when it is being taken up by checking out the agendas posted for the week.

After our Town Meeting break, the Senate will be returning 'in person' to the Statehouse. With the rapid decline of Omicron's

impact, many aspects of normal life are returning. For two years, we have been legislating almost entirely on Zoom. It will be wonderful to work together, face to face, again. Upon our return, the Legislature begins a fairly intense week or two of 'Cross Over'. To become law, bills need to be considered and passed by both the House and the Senate. Cross Over is that period in which all of the bills we hope to enact into law need to be voted out of our committees, and get passed by whichever body it originated in - the House or the Senate. Once passed by one body or the other, the bills 'cross over' to the other body for consideration. Cross Over is assumed to be roughly the half way point in the legislative session.



Paving Grant Application - Hortonville TH-1: Jeff Chase mentioned last month's meeting he spoke about the paving grant for Hortonville Road from Shunpike Road to Shrewsbury with the budget as of last month but the price of asphalt is going up. Jeff said he will send the application in seeking the full amount of the grant. The deadline to apply for the grant is April 2<sup>nd</sup>. He mentioned the prices will be going up as fuel costs are rising. Clinton was talking with Tom Fuller who suggested to reclaim the road this year because of the rising costs and pave next

year. Hopefully by this fall the cost will start to come down. Mark thought it a good idea to reclaim and let set over the winter which would give it a chance to settle. The grant is good until June of 2023. Jeff will take some pictures of the road condition.

iii. Structures Grant - Summit Road - Bid Results: Jeff Chase stated we got five bids late January good for 60 days which will expire the end of this month prices varied from \$230,000 to top one for Markowski at \$469,000 with other bids of \$383,000, \$395,000, and \$417,000. G and N was the low bidder they had done some work in Shrewsbury according to Otter Creek. They are more owner operator vs the others are larger companies. Jeff was going to give them a call but didn't have a chance. We have the grant money and have until next year to spend it. Pre-cast has not been effected as much as paving. The labor rates are going up, equipment rates are going up, and other rates are going up. If we don't go with this bid right now we are going to lose the money or just cost us more. We could go back and try to get another grant which won't be until this fall then will have to put it back out to bid and the price could be more than \$400,000. We talked about doing it some other ways like

buying the culvert and hiring the rest out with the actual install which would pose some other challenges too with risks. The grant is for \$180,000 we got \$180,000 the match is \$20,000 we are with the engineering somewhere around \$40,000 above that which leaves \$60,000-\$70,000 depending on some other priced items in the bid which they may or may not do. We do have funds in Culvert Fund of approximately \$60,000 and maybe able to use some ARPA funds. Mark said we may have to reach out to see if that qualifies. Clinton has heard they are leaning more toward infrastructure on the ARPA funds. If the budget of your town is under 10 we can use some of the ARPA funds of maybe \$30,000-\$40,000. Clinton reached out to the state for hydraulic study but they are way behind with COVID so he doubt we will see anything there. We need to verify ARPA funds. There are funds available in the Bridge Fund. We will hold a Special Meeting when have more information. Jeff will call tomorrow to see if Companies will hold our price for another week.

b. Treasurer – David Johnson – Monthly Income & Expense **Report:** David gave a report on the income and expenses with copies of the report handed out for the Select Board. He also said the audit is on track to finish the FY 20 audit and the Auditor would like to be present at the April 12th select board meeting.

c. Mount Holly Planning Commission Update - Jon McCann: The Planning Commission has been reaching out to people with knowledge of the plan utilities and facilities of the town for the Town Plan. They have had letters come in from Fire and the Library with more to arrive soon. They have other

coming in on the transportation plan. They will present a draft in April. Jon McCann stated there is a public hearing coming up on March 16th. Mark asked Jon how many Subdivision permits have they had this year and he replied 3 with one withdrawal. One had 3 lots to begin with but reduced to 2 lots.

d. Mount Holly Conservation Commission Update: Francis DeVine spoke on behalf of the Conservation Commission. He said as there were

people traveling this month they were not able to hold an official meeting but did hold an informational meeting. The agenda for this month was tabled and will be held next ongoing month. On March 8th, 2022, the Selectboard of the Town of Mount Holly, Vermont, adopted a new "Traffic Ordinance" pursuant to the provisions of 24 V.S.A. § 59. This notice is published pursuant to 24 V.S.A. § 1972 to inform the public of this adoption and of the citizens' right to petition for a vote to disapprove this adoption.

T.H. #1 (Tarbellville Road, Belmont Road, and Hortonville Road) -A maximum speed of 35 m.p.h. from the intersection of VT. Route 155 easterly village limits, 500 feet from the intersection of T.H. #2; then a maximum speed of 25 m.p.h to the intersection of T.H. #17; then a maximum speed of 40 m.p.h. to the intersection of T.H. 20; then a maximum speed of 35 m.p.h to the intersection VT. Route 103: then a maximum speed of 35 m.p.h. to the Shrewsbury Town Line.

T.H. #2 (Church St and Healdville Road) - A maximum speed of 25 m.p.h. from intersection of T.H. #1 easterly 1320 feet; then a maximum speed of 35 m.p.h to the intersection of VT. Route 103.

T.H. #4 (Old Turnpike Road) - A maximum speed of 30 m.p.h. from VT. Route 103 to T.H. #1; then a maximum speed of 35 m.p.h. to the Shrewsbury Town Line.

T.H. #5 (portion known as Shunpike Road) -A maximum speed of 35 m.p.h. for the entire length.

T.H. #11 (portion known as Shunpike Road) - A maximum speed of 35 m.p.h. for the entire length.

T.H. #20 (Gates Road) - A maximum speed of 35 m.p.h. for the entire length.

T.H. #22 (Maple Hill Road) - A maximum speed of 35 m.p.h. for the entire length.

T.H. #23 (portion known as Maple Hill Road) - A maximum speed of 35 m.p.h. from the intersection of T.H. #22 to southernly village limits, 500 feet from the intersection of T.H. #1; then a maximum speed

of 25 m.p.h. to the intersection of T.H. #2.

T.H. #26 (Lake St)A maximum speed of 25 m.p.h. for the entire length.

T.H. #30 (portion known as Shunpike Road) -A maximum speed of 35 m.p.h. for the entire length.

#### CITIZENS' RIGHT TO PETITION FOR VOTE

Title 24 V.S.A. § 1973 grants citizens the right to petition for a vote at a special or annual Town Meeting to disapprove ordinance adopted by the Selectboard. To exercise this right, citizens must present to the Selectboard or the Town Clerk a petition for a vote on the question of disapproving the adopted ordinance signed by not less than five percent (5%) of the Town's qualified voters. The petition must be presented within forty-four (44) days following the date of the adoption of the ordinance. Unless a petition requesting a vote is filed pursuant to 24 V.S.A. § 1973, the adopted "Traffic Ordinance" shall become effective sixty (60) days from the date of said adoption.



- iv. Discussion of whether valuable services like "Reinbow Riding Center" fall under Education. Commissioner Sullivan noted it could potentially be put in a section for Social Services. Commission Schulz suggested putting it in the category that seems most appropriate, and also cross-reference it in other relevant categories. The Chair stated it might be worth having a Social Services subcategory under Utilities and Facilities.
- v. Commissioner Schulz inquired if the categories or chapters of the plan are fixed, and if Education is separate from other services. He suggested that there could be a category of "Education and Social Services", and Facilities and Utilities would be more "health and safety". The Chair responded that the categories are not fixed. The statute (24 V.S.A. § 4382) requires 12 categories that are required to be addressed each with a list of details that have to be included, but it is understood that the Town can organize the Plan however we wish. Education and Social



Services could also include childcare and eldercare. The Chair noted that the childcare situation is poor with few, if any, options.

vi. Commissioner Sullivan stated there is a group of homeschooling parents in town, but she is unsure of who organizes it. Suggested as a question for MHS Principal.

vii. Review of Middle School and High School options. Will probably want to mention the options in the Plan.

viii. Discussion of school choice options: Burr & Burton Academy (public for Manchester, VT), Mount Saint Joseph Academy catholic school in Rutland, Okemo Mountain School, Expeditionary School at Black River, Long Trail School, Mill River, River Valley Technical (Springfield), Stafford Technical School (Rutland)

ix. It was suggested the Chair could speak with Andrea Auld, PTSA

- x. Discussion of education related bussing. Mention of a bus stop change due to blocking entrance to Fire/Rescue. Thoughts about having an actual bus stop. Wondered if this is a question for Devon and the Transportation Plan. Anecdotes that ridership on elementary school bus is low.
- xi. Discussion about virtual learning. Mention of VTVLC -The Vermont Learning Cooperative (online courses for middle and high school students) and Two Rivers Virtual Learning Academy. The Chair will ask the MHS Principal about virtual learning.
- xii. The Chair asked if there was anything in other Towns' Plans that the Commission might want to explore. The Chair recalled speaking with MHS Principal last year, and that it seemed that the cost of living and housing were significant issues so there will almost certainly be a relationship between education plan and the housing plan. Commissioner Schulz expressed dissatisfaction that when it comes to education so much depends on the number of students and the declining number of students, and there is not much that can be done about it in the short term. Commissioner Sullivan stated that as the Commission looks at the Housing Plan they need to be cognizant of when housing isn't available there are fewer families and students so it definitely impacts the school.
- xiii. Review of who to reach out to for information: Andrea Auld (PTSA) and Craig Hutt Vater (MHS Principal). Commissioner Schulz suggested seeking input from a school board member.
- xiv. Commissioner Schulz asked if there is any data or anecdotal stories about how the influx of people to Vermont and the housing crisis is changing the demographics of our community. Are people coming with school age children, or is it mostly older wealthier people without children? Commissioner Jim Seward stated he thought it was a little of both. Stephen Michel noted how the grade school is up to 110-115 students with a capacity for 125. Commissioner Sullivan asked if the US Census would have data. The Chair spoke about how the Poultney Town Plan referenced a 2018 American Community Survey that the Commission should look at. This was about certain demographic trends for education. The Chair stated they had tried to figure out information about growth trends as required for the local hazard mitigation plan, but weren't able to get clear answers. The Listers could have information about the rate of housing transfers, but may not know if they are residents or have children. Commissioner Sullivan said the school gets information about what children will be coming in future years, so Raye Lin, school secretary, knows the births in town. Commissioner Schulz wondered if local brokers would have information about who has bought and what the demographics look like. The Chair noted this information will probably be needed for the housing plan.
- xv. Possible questions for Principal Craig Hutt Vater: How does he project what his future enrollments will be? What challenges are there? Same kind of questions that have been asked in previous sections (i.e. money for repair and maintenance, capital investments, facilities). Kindergarten is five full days and universal preschool is offered part time. Is pre-k only being part time a matter of funding or staffing.

1. Commissioner Sullivan stated the letter did a good job documenting the

### Mount Holly Biodiversity update

It's been a long, strange winter and project observations have been slow for almost everyone. Now March has began and day length gets longer there are more opportunities to get out and find the amazing biodiversity in Mount Holly. The <u>Mount Holly Biodiversity project</u> is now in its second year of volunteers collecting important information about our environment. The project needs people who can report common species (birds, squirrels, deer, trees, etc.) and well as keep an eye out for the rare ones. Very soon we will start seeing early shoots of spring wildflowers and it's very helpful to submit photos of early growth as well as mature plants and flowers. Also, early migratory birds will soon be here and first sightings of plants and animals are very important to learn about their phenology (when they appear) and changes that might be happening. If you have helped in the past year, thank you, we hope you will continue this year. March Madness. Can we plant now?

As March gets started, we can't be sure if it's going to snow or be mud season. We have seen some brave sprouts peeking up from bulbs such as irises, lilies, snow drops, and early crocuses. Some would call this "Fool's Spring". Nevertheless, there are some garden preparations we can be doing, including planting onions, petunias, and coffee!

If you haven't yet pruned your fruit trees (apples, pears, cherries, etc.) these mild days might be your last chance to get the pruning done before the trees break dormancy. After pruning them, give them a first spray coating of Dormant Oil to smother the over-wintering eggs left by last year's pests.

This week (March 7-9) I planted my onion seeds (3 varieties: Ailsa Craig, Redwing, and Patterson) along with four varieties of Wave Petunias (blue, purple, pink, & silver). These plants are slow to start and require a long head start before transplanting out in late May. Onion seedlings produce better final onions and are much cheaper than sets so are worth the extra effort. You can also buy onion seedlings ready to plant from many seed companies and garden stores later in the season. Most other seeds can wait a bit longer before starting. More on this in the next article.

Looking for a fun project? Try growing your own coffee! I have just planted a flat of selected Honduran Arabica coffee seeds and will be looking for adoption outlets when

they are ready. Coffee plants naturally prefer to grow in shade so make a nice house plant with their dark green leaves and are a great topic for conversation. Coffee trees are small so will get to only 2-4 ft tall in a pot. They are not winter hardy and will need to come inside for the winter. For the adventurous, I still have a supply of coffee seeds available for free that you can plant for yourself. Contact me at 802-259-2311.



### Vermont Home Gardener Mud Season Gardening

Snow has been replaced by slippery mud, a sure sign that spring is almost here! We now get just over 12 hours of daylight per day now and that stimulates new plant growth. It also makes our gardens irresistible on warmer days. Don't be tempted to get too ambitious just yet, but there are several jobs that can be done before digging soil. Houseplants and indoor sheltered garden plants would benefit from a feeding now. I prefer to use a liquid fish fertilizer for its slow release of micronutrients.

Hidden deep in all that leaf litter in your gardens are many overwintering beneficial creatures that need a little more time to awaken and get to work. Let them have this time and wait until we pass the freezing nights of April before clearing up those

beds. It's also important that cold, wet soil not be disturbed yet. Let the water drain out for few more weeks before digging. Even walking across a wet, squishy lawn now is hard on the soil and roots. Still, there are plenty of mud season jobs that can be done now! A couple questions we'll answer in this article include "*What seeds can I plant indoors now?*" and *What outdoor jobs should be done now?*"


