

DOG CENSUS NOTICE – Town of Mount Holly

Vermont State Law, requires all dogs six months of age must be licensed within 30 days. Newly acquired animals older than 6 months must be licensed immediately. All dogs will be licensed by April 1 each year or a penalty fee will be added after April 1 in the municipality in which they are harbored. In accordance with the law, the Town of Mount Holly is conducting a census of all dogs and puppies harbored within the Town. Failure to license your dog(s) can result in a fine of \$50 - \$100 per dog per offense.

We are asking all Town of Mount Holly residents to complete and return the Affidavit of Dog Ownership at the bottom of this page. Please return to by mail or in person to: Mount Holly Town Clerk, 50 School St., P.O. Box 248, Mount Holly, VT 05758, within 30 days.

- If you have unlicensed dogs, you will also need to complete and submit:
- The licensing form, which can be filled out at the bottom section of this form.
 - A current, signed rabies vaccination certificate for each dog
 - Proof of spay/neuter (if applicable)
 - The appropriate licensing fee
